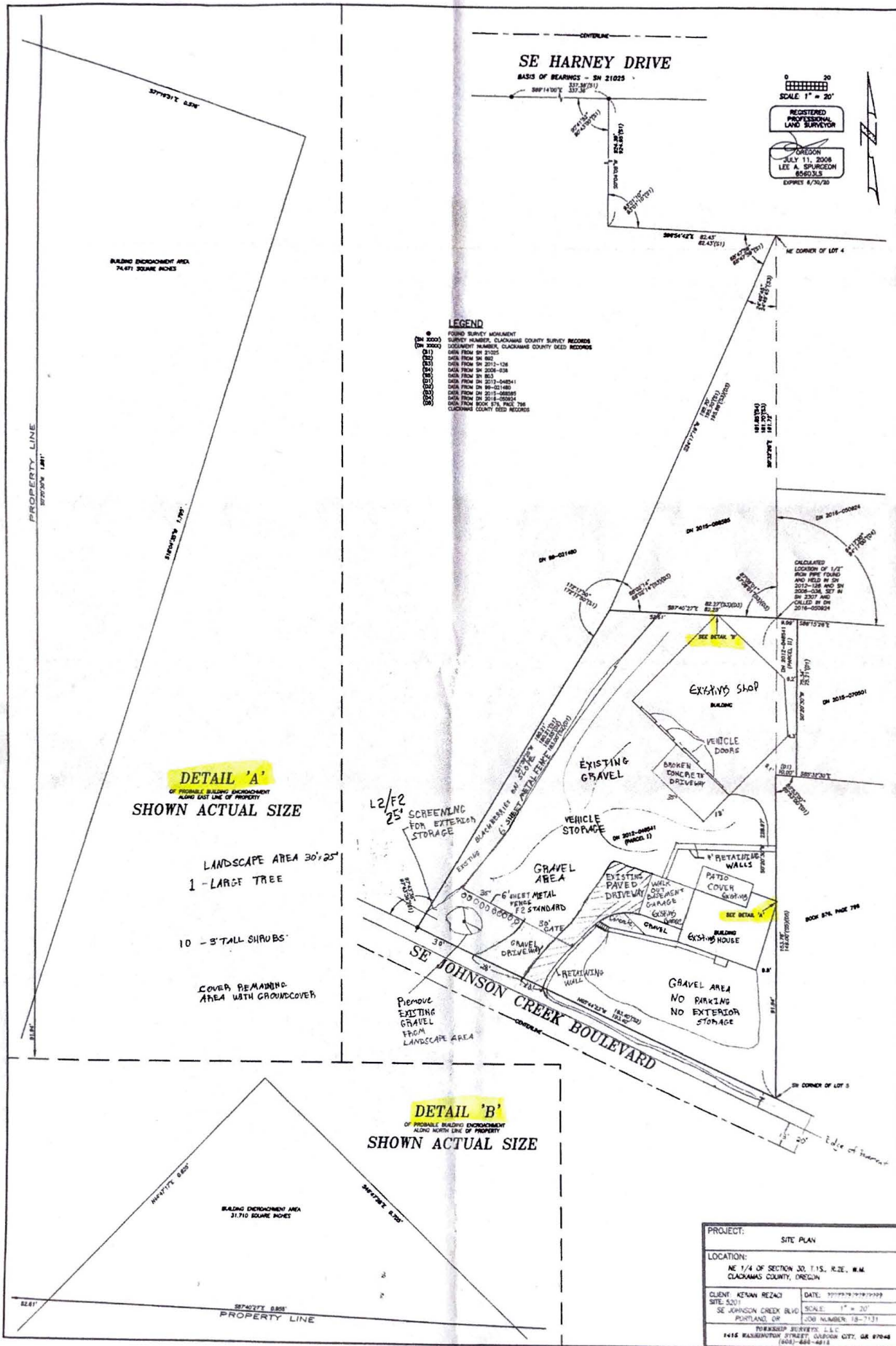
APPEAL DECISION

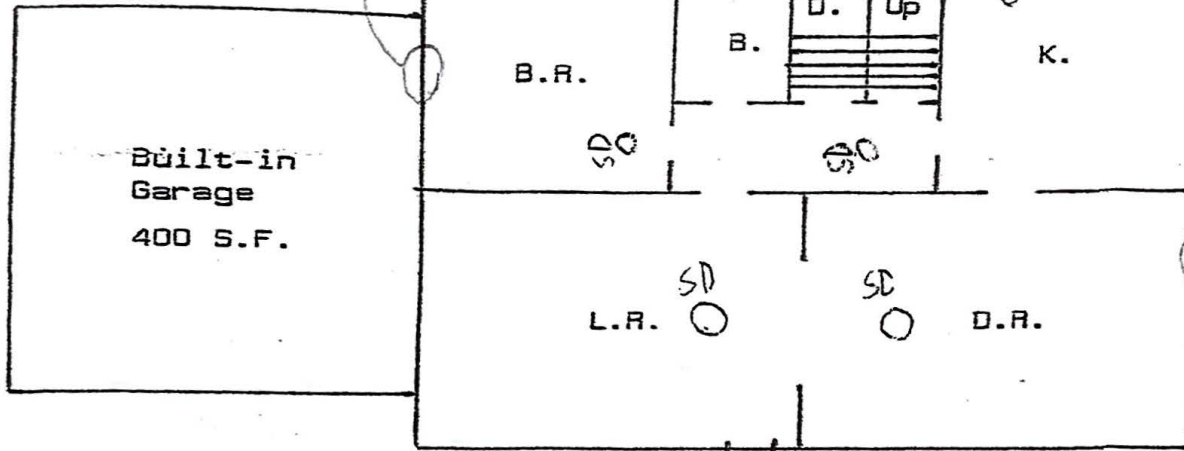

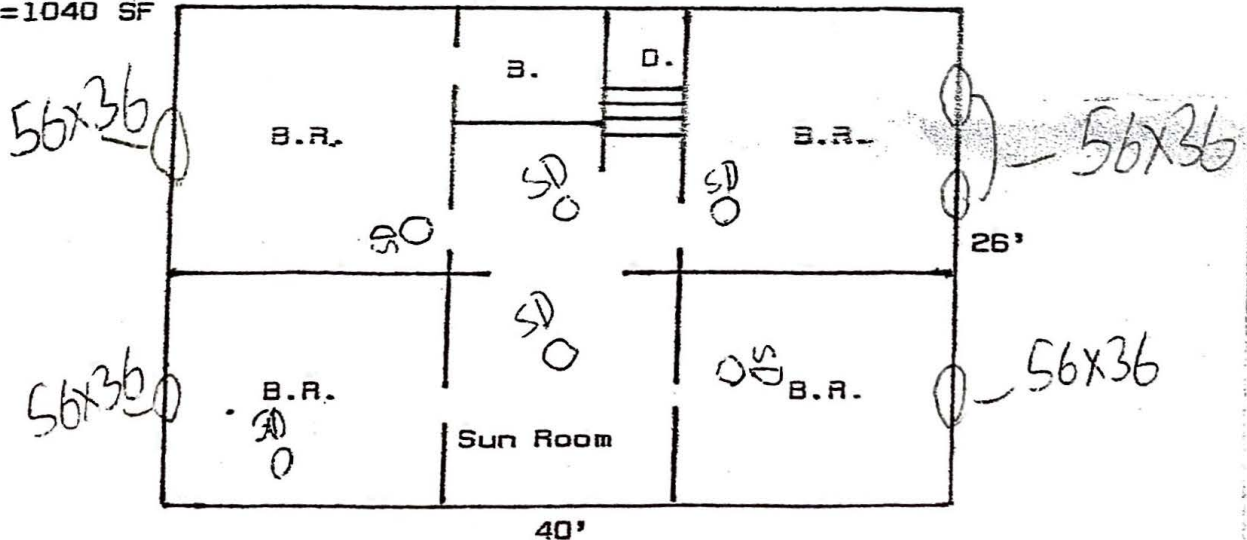

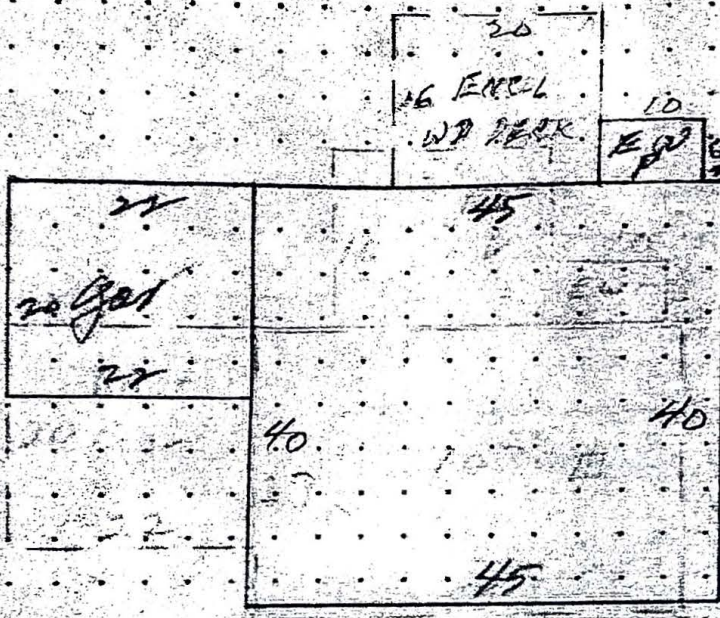
