Appeal item 1

Code Section 1109.12.3 and ICC 904.3

Requires Code Section 1109.12.3 requires an accessible service counter be provided at the Service Seafood Department.

Code Section 904.3 addresses the approach and floor space required for accessibility.

Proposed Design WinCo proposes to install an assistance buzzer at the Service Seafood Case to alert an Employee to provide assistance to meet the customers needs.

The buzzer will be installed to meet accessibility requirements per 2009 ICC A117.1-308 for reach and 309 for operation.

Reason for alternative Modifying the existing area to accommodate a service counter is would require extensive remodeling and layout of equipment which is cost prohibitive.

In order to accommodate the specific needs WinCo will provide training to employees responsible for the Service Seafood area to provide items and services to individuals requiring assistance by walking to the customer side and deliver product personally.




