## **Impact Statement**

## Purpose of Proposed Legislation and Background Information

The Focused Intervention Team Community Oversight Group (FITCOG) commenced in June 2021 in response to the ongoing gun violence crisis in the City of Portland. The FITCOG mission is to work closely with the commissioner-in-charge of the Portland Police Bureau (PPB), the leadership of the PPB, and Focused Intervention Team (FIT) members to understand, inform, and provide real-time oversight of the FIT; and assist with recommendations to the city's efforts to reduce gun violence through prevention, intervention, and response.

This report appoints three community members to serve on the Focused Intervention Team Community Oversight Group. They will serve alongside current FIT/COG members for the first two years of the FIT/COG's work, through June 4, 2023, and are eligible for reappointment at that time for up to two years. These appointments were made from the current pool of applicants for FIT/COG, which consists of applications received in July 2022. Applications not included in this appointment will be kept on file for up to one year and reviewed for upcoming appointments.

### **Financial and Budgetary Impacts**

There is no direct financial or budgetary impact related to this appointment.

### **Community Impacts and Community Involvement**

- All Portlanders may be impacted by the Focused Intervention Team (FIT)'s work, and therefore by the impact of the Focused Intervention Team Community Oversight Group's work overseeing the FIT.
- Recommendations from FIT/COG are presented to the Commissioner-incharge of the Police Bureau, as well as the Focused Intervention Team and the Chief of Police or designate, on a rolling basis. Community involvement is an important part of each of these processes.
- FIT/COG meetings include portions which are open to the public and FIT/COG conducts community engagement as well to try and maximize Portlanders who have input into discussions in FIT/COG's areas of work.

## 100% Renewable Goal

Although it is incorporated into the sustainable procurement policy, this specific resolution does not impact the city's use of energy or pursuit of the 100% renewable goal.
