

Interim Director's Update – September 2022

General Updates

- Executive Leadership Roles at PHB
 - Molly C. Rogers is now the PHB Interim Director after serving three and a half years as Deputy Director.
 - Matthew Tschabold is now serving as Interim Deputy Director. Matthew has been with PHB for nearly eight years, serving for much of that time as the bureau's Policy and Planning Manager.
 - Leslie Goodlow, LMSW, continues in her role as the Bureau's Equity & Business Operations
 Manager, but will additionally be overseeing the Neighborhood Housing and Preservation Team
 during this interim period, as well as serving as staff liaison to Commissioner Dan Ryan's office in
 matters pertaining to the recruitment of the new Bureau Director.
- PHB sent legislative issue sheets to City Council for their consideration and inclusion in the City's State
 Legislative Agenda for the 2023 session including measures to address the homeownership gap, reform
 Private Activity Bonds, extend HOLTE sunset, tenant protections, and affordable housing preservation.

- Effective July 1, 2022, Inclusionary Housing projects seeking approval for the <u>Multiple-Unit Limited Tax</u>
 <u>Exemption (MULTE)</u> program will pay the processing fees due to Multnomah County at permit issuance.

 Current rates are \$850 per unit with a \$9,000 maximum per building.
- On July 29, 2022, <u>changes to the evaluation of applicants and security deposits</u>, PCC 30.01.086 and 30.01.87 respectively, became effective to provide additional clarity and simplicity for compliance.
- Rental Services Commission held a listening session to hear from landlords and tenants about their personal experiences or concerns with the rental market in Portland.
- In the absence of a current AFFH reporting requirement, PHB in coordination with the Fair Housing Advocacy Committee, is developing a localized, Portland specific, assessment to update our Fair Housing Action Pan and policy recommendations to affirmatory further fair housing.
