# **November Council Items**

- Reappoint Ernesto Fonseca to PHAC

### **General Updates**

- Strategic Plan/Director Search staff survey closed and focus groups are being scheduled. Focus groups will
  also be held with PHAC, and North-Northeast Oversight Committee. Multiple individual interviews of
  external subject matter experts will also be held. Focus groups and interviews facilitated by Shari Dunn.
- Work session on pre- and post-inclusionary housing MULTE scheduled with Council on November 1.
- Proposals for <u>Metro Bond + TIF Opportunity Solicitation</u> due by 3pm November 4.
- Calibration analysis of program priority areas underway for the inclusionary housing program. Priority
  areas are off-site options, reconfiguration, homeownership program, and tax exemption at 5:1 FAR or
  greater.
- In the absence of a current AFFH reporting requirement, PHB in coordination with the Fair Housing Advocacy Committee, is developing a localized, Portland specific, assessment to update our Fair Housing Action Pan and policy recommendations to affirmatory further fair housing.
