WHEREAS, W.K.Smith and Debbie H.Smith, his wife, Walter V.Smith and Edith J.Smith, his wife, and Susan W.Smith, widow, have made, executed and delivered to the City of Portland a deed of conveyance to the following described real property, to-wit:

Beginning at a point 705.35 feet south and 525.24 feet west of the southwest corner of lot No.6 in block lettered "K" in Greenway Addition to the City of Portland, said point being marked by an iron pipe one inch in diameter and twenty-six inches long driven into the ground to a depth of twenty-four inches, said point of beginning being the northeast corner of the tract hereinafter described, and running thence south parallel with the southern extension of the west line of said Greenway Addition 100 feet to a point marked by an iron pipe one inch in diameter and twenty-six inches long driven into the ground to a depth of twenty-four inches, said point being the southeast corner of said tract; thence west at right angles to the line last above described, 100 feet to a point marked by an iron pipe one inch in diameter and twenty-six inches long driven to a depth of twenty-four inches, said point being the southwest corner of said tract; thence north parallel with the southern extension of the west line of said Greenway Addition, 100 feet to a point marked by an iron pipe one inch in diameter and twenty-six inches long driven to a depth of twenty-four inches, said point being the northwest corner of said tract; thence east 100 feet to the place of beginning, containing 10,000 square feet.

X Also a right of way for a force water main from Talbot Road to the reservoir site hereinbefore described, the same being a strip of land 20 feet wide, 10 feet thereof being on each side of the following described center line, to-wit: Beginning at a point in the center of the present travelled way of Talbot Road 343.55 feet south and 255.44 feet west of the southwest corner of Lot 6, in block lettered "K", Greenway Addition, to the City of Portland, said point being marked by an iron pipe one inch in diameter and twenty-six inches long, driven flush with the ground, and running thence south 36 degrees 43 minutes west, 451.3 feet to an iron pipe one inch in diameter and twenty-six inches long driven to a depth of twenty-four inches, marking the northeast corner of a certain tract 100 x 100 feet conveyed to the City of Portland as a reservoir site. Area included in above described right of way 9131 square feet, more or less.

Also a right of way for a distribution water main from the real property above described to the northwest corner of lot seven (7) in block one (1), Council Crest Park in the City of Portland, the same being ten feet wide on each side of the following described center line, to-wit: Beginning at an iron pipe one inch in diameter and twenty-six inches long driven into the ground to a depth of twenty-four inches, marking the southeast corner of the tract hereinabove described, and running thence

south 30 degrees 39 minutes east, 195 feet to a point; thence south 41 degrees 18 minutes east, 455.5 feet to a stake at the northwest corner of lot seven (7) in block one (1), in said Council Crest Park, the total length of said proposed right of way being 650.5 feet, the total width thereof being 20 feet and the said right of way containing 13,010 square feet, more or less.

WHEREAS, said real property has been deeded to the City as a site for the construction of a reservoir on Council Crest, with rights of way to said reservoir for force main and rights of way for distributing main from said reservoir, and

WHEREAS, the Council deems it for the best interests of said City that said real property be accepted by the City;
