Subject: Picketing by Minority Contractors at Chuck's Market, 2415 N Williams

Sir:

There is a small market being built at 2415 N Williams Ave. It is called Chuck's Market and is being financed partially by federal funds. The bids were let by the Portland Development Commission, and the general contractor is Juhr Construction, Inc., phone number 235-3158, site phone number 282-9396. The man in charge of the construction site is Mike Lay.

Approximately a week ago, a Negro male individual by the name of John Berry (spelling may be Barè). Mr. Berry claimed that he represented the Minority Contractors, and he did not see any black faces in the construction crew. There have been several contacts between Mr. Berry and Mr. Lay, who is in charge of the construction site. since that time.

This morning, April 28, 1982, at approximately 0900 hours, 12 people from the Minority Contractors occupied the construction shack, which is on the construction site. Mr. Lay asked them to leave, and was given an ultimatum. Either they hire black people in the construction crews, or the construction site will be shut down and if that didn't work, the construction site would be burned down. There was also the threat of vandalism to the site.

The deadline was 11:00 a.m., which passed without any activities because contact had been made between Mr. Berry and a member of the Association for General Contractors. It is unknown at this point what kind of agreement was made or what will take place at this meeting.

Meanwhile, there are approximately 10 picketers with signs asking for jobs and criticizing the Portland Development Commission.

Mr. Lay is keeping a journal of activities as well as what was said between the different parties on the site.
