Emergency Ordinance

*Authorize contract with the lowest responsible bidder for the Jade Montavilla Transportation Improvements Project

Passed

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Bureau of Transportation developed the Jade Montavilla Transportation plan in 2017, the plan detailed a range of safety and other improvements.
2. The Bureau of Transportation and the Oregon Department of Transportation entered into an Intergovernmental Agreement in 2019 to fund the project through Grant number TR000298.
3. Design engineering and right of way for the project will be completed in early 2023.
4. The Bureau of Transportation has funds budgeted in FY 2022 and proposed FY 2023 for construction, inspection and management of the project.
5. The Bureau's level of confidence in the cost estimate for this project is moderate, the plans are mostly complete and major issues are resolved, however the current bidding environment is volatile.

NOW, THEREFORE, the Council directs:

- A. The Chief Procurement Officer is authorized to facilitate the competitive solicitation process in accordance with City Code 5.34 to obtain the lowest most responsible bidder.
- B. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to award, negotiate and execute a contract, provided the contract has been approved as to

Impact Statement

Purpose of Proposed Legislation and Background Information

- Authorize Bidding for the federally funded Jade Montavilla transportation improvement project.

Financial and Budgetary Impacts

- The total cost for design and construction of this project is \$8,965,000 funded primarily with federal funds and SDCs. Grant number TR000298.
- The project is budgeted under T00710.C42.
- This ordinance is to authorize bidding of the construction contract for this project.
- The construction for this project is budgeted and it is necessary to take the contract to council to authorize bidding.

Community Impacts and Community Involvement

- This project will benefit the community by providing needed transportation improvements.
- There has been extensive community involvement in both the planning and design phase of the project.

Budget Office Financial Impact Analysis

This legislation provides PBOT authorization to contract with the lowest bidder for the Jade Montavilla Transportation Improvements Project, which includes construction of multi-modal improvements on key pedestrian and bicycle routes within and connecting to the Jade District and Montavilla Neighborhood. The project is funded primarily through federal funds and system development charges, with \$5,531,456 total budgeted in the bureau's FY2022-23, 5-year CIP.
