MINUTES - FEBRUARY 22, 1973

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman, Nick Sckavone, on February 22, 1973 at 7:00 P. M. The meeting was held in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Those present were Nick Sckavone, Don Casciato, Dr. Jack Battalia, Dr. Ken Wilhelmi, Dr. R. Lorey, Bob Hyle and Sam Singer.

The minutes of the December 13th meeting were read. Don Casciato made a motion they be accepted as read. Seconded by Dr. Jack Battalia. Motion carried.

The receipts and disbursements for December were read. Dr. Ken Wilhelmi made a motion they be accepted. Seconded by Dr. Jack Battalia. Motion carried. The receipts and disbursements for January were read. Jack Battalia made a motion they be accepted. Seconded by Don Casciato. Motion carried.

The chairman told of the commission being presented with approximately \$1600.00 in doctor and hospital bills for Roger Buckskin who had suffered a broken jaw in his September fight here. He also explained that it had been necessary to withdraw this amount out of the Medical Welfare Fund Savings to cover these bills. A discussion followed as to just what was the extent of liability of the Boxing Commission in regards to any further large bills of this nature. It was decided to contact the City Attorney to ask for an opinion as to a ceiling of what the commission should pay.

Nick Sckavone reported that the recent Golden Gloves had been one of the most successful in years and complimented Don Casciato and his large group of helpers for making it such a success.

It was announced that due to lack of personnel in the Police Bureau there would be no further inspectors attached to the Boxing Commission to license boxers and wrestlers. This procedure was to be left to the secretary who could seek assistance from Al Zornado or Bob Cosby if necessary.

A letter to Mayor Schrunk was read by the chairman and a copy of his reply given to each commissioner.

After a discussion of the record of Mescall and the feasibility of the Hopkins-Bolden match, the commissioners agreed that the card should be a very good one. Dr. Battalia complimented Sam Singer for doing a wonderful job as a fight promoter and stated most of the fights presented here were very well matched.

Sam Singer asked if Clyde Quisenberry had given any indication as to whether he was ready for Pro-Am fights or not. He was told nothing had been decided as yet.

He also stated that he had had a request from Don Manuel, who is Eddie Jones manager, that a neutral referee work this next fight. However, it was explained to him that the referees in Portland do not vote on the outcome of the fights. He then asked for a neutral or out of state judge. After some discussion on this matter, Dr. Jack Battalia made a motion that we bring in Jim Rondeau as a guest judge for the next fight on March 1, 1973, providing there was no great amount of publicity in the papers in this regard. Seconded by Don Casciato with the exception that the extra costs be picked up by Sam Singer. Motion carried.

There being no further business the meeting was adjourned.

PORTLAND MUNICIPAL BOXING AND WRESTLING COMMISSION

MINUTES - APRIL 18, 1973

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman, Nick Sckavone, on April 18, 1973, at 7:00 P. M. in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Those present were Nick Sckavone, Don Casciato, Dr. Ken Wilhelmi, Dr. Jack Battalia, Sam Singer, Mutt Cosentini, George Yerkovich, Bob Cosby, Paul Weitzel, Dr. R. Lorey, Jim Cassidy and Eddie Volk.

The minutes of the February 22nd meeting were read and approved by a motion made by Dr. Wilhelmi and seconded by Don Casciato.

The receipts and disbursements for the month of February were read. Dr. Jack Battalia made a motion they be accepted as read. Seconded by Don Casciato. Motion carried. The receipts and disbursements for the month of March were read. Don Casciato made a motion they be accepted. Seconded by Dr. Ken Wilhelmi. Motion carried.

Nick Sckavone explained that in the contract forms furnished by the Commission it stipulated that the commission was to collect 1% from the boxers purse and 1% of the gate from the promoters gate. This amount was to be put into the Medical Welfare Fund and used at the discretion of the Commission to alleviate and help a boxer defray the costs of any treatment for any injury suffered in the ring during any fights under their jurisdiction. He felt that in no way was the commission responsible for the full amount of any injury but as in Roger Buckskin's case, we had the money, which was good. However, he had asked the secretary to write to the doctor stating that this reimbursement was voluntary and that in no way were we responsible for the bills on Buckskin. He further explained that the contract the fighters sign waive the responsibility of the City of Portland and the Boxing Commission. Nick also stated that he had talked to the Assistant City Attorney, Walt Yeager, who agreed to talk to us about the revision of the Rules and Regulations. They are now in a rough draft form but should be put in book form. Since a waiver signed in the State of Oregon is not valid, Dr. Ken Wilhelmi asked what protection do we legally have. The chairman said that he had asked Walt Yeager to look at the commission rules and it was agreed that Nick Sckavone, Dr. Jack Battalia and Bob Weitzel would meet with Mr. Yeager at a convenient time for both Mr. Yeager and Dr. Battalia. It was further mentioned that we do have a liability insurance coverage for the commission.

The chairman stated that he had received a letter from Jim Rondeau concerning the NAB. F. Convention in Seattle, Wash. on June 21, 22, and 23. Nick had written to Jim and said since the meeting was so close to Portland that he felt most of the commission could be present.

April 18, 1973

A letter had been received from the President of the Wrestling Assn. in regards to holding the Wrestling Convention in the states in place of Caracus. Nick had replied to this letter stating that he had no objections as to where it was held.

It was also mentioned that the W. B. A. and the NAB. E. had gotten together to form ~~one~~ rating committee, *TO MAKE FOR THE FIRST FIVE.*

The matter of House Bill 2556 was brought to the attention of the commission. It had been proposed that that portion of the bill in which the various Veterans organization are to receive part of the surplus turned over to the City of Portland be deleted and changed to read that the City may disperse this money to the Parks, Amateur Boxing or any other amateur athletic event. It was suggested by Dr. Battalia that some of the commission go to any committee hearings in regards to this bill. The secretary stated that a member of the Mayor's office had written that he would inform him when this hearing would be coming up so that they could attend.

Mutt Cosentini made a motion that we sanction the fight card by Three Star Sports on April 19, 1973, at the P. I. Building as follows. Seconded by Don Casciato. Motion carried.

The subject of bills outstanding by Frank Sturgill for rent of the P. I. was brought up. After some discussion it was stated that until such time as the commission received this information in writing, it was of no concern to the commission.

Various discussions followed in regards to the radio talk show in which Mike Morton had appeared. It was decided that this type of action should be ignored.

George Yerkovich told of the problems of Denny Moyer in regards to a lein in which he is involved and not being able to fight here. Sam Singer stated that he hoped to put on a fight in May and have Denny on that program.

There being no further business the meeting was adjourned.

PORTLAND MUNICIPAL BOXING AND WRESTLING COMMISSION

MINUTES - JUNE 25, 1973

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman, Nick Sckavone, on June 25, 1973, at 7:00 P. M. in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Those present were Nick Sckavone, Don Casciato, Mutt Cosentini, Dr. Wilhelmi, Dr. Battalia, Dr. Lorey, George Yerkovich, Tex Hager, Sam Singer, Abe Tantzman and Harvey Isaacs.

Minutes of the previous meeting were read and the following changes suggested by Dr. Battalia: The initials N. B. A. changed to N. A. B. F. and the item in regards to the rating committee of the W. B. A. and N. A. B. F. be changed to read "form one rating committee to agree on the first five." Mutt Cosentini made a motion to accept the minutes with those changes. Seconded by Don Casciato. Motion carried.

The receipts and disbursements for the month of April were read. Dr. Battalia made a motion they be accepted. Seconded by Dr. Wilhelmi. Motion carried. The receipts and disbursements for May were read and accepted on a motion made by Mutt Cosentini and seconded by Don Casciato.

Nick Sckavone gave the following report on the N. B. A. F Convention held in Seattle, Wash at which three of the commissioners and the executive secretary were present. Our advisor, George Yerkovich, was also in attendance. The first day was taken up with routine matters and various reports. The only controversy was in the changing of ratings by Ramon Valesquez of Mexico and the tendering of the resignation from the ratings committee by Robert Turley of the California Boxing Commission. The president of the N. A. B. F. refused his resignation and Bob Turly agreed to serve if they would not tamper with the ratings committee list. Bobby Lee, President of the W. B. A., Hosea Soamian of the W. B. C. and R. Turley of the N. A. B. F. were appointed on a committee to try and agree to ratings on boxers.

Mrs. Eileen Edmond, the only women boxing promoter in the world, was present and she reported on her tax problems. This matter was referred to the legal committee.

Delby Shirlee gave a report on amateur boxing on pro am cards and although at the present time there were a few snags, it could probably be worked out.

The president appointed Jim Deskin of Nevada, Nick Sckavone of Oregon and Robert Voit of California to the nominating committee.

Dr. Jack Battalia gave an excellent report on the medical portion of our boxing program.

Members of the N. A. B. F. will be allowed to make presentations of various trophies to any N. A. B. F. champions.

Dick Sadler, manager of George Foreman, impressed the delegates with his comments.

June 25, 1973

The nominating committee presented the following slate of officers for election: President, James Rondeau of Washington; First Vice-President, Bill Miller of Hawaii; Second Vice-President, Tom Smith of Texas; Secretary, Roy Tennison of California; Treasurer, George Yerkovich of Oregon; Delegates at Large, Raul Meseas of Mexico and Nick Sckavone of Oregon. The convention gave a unanimous vote to the slate of officers recommended by the nominating committee.

The sixth annual convention of the N. A. B. F. will be held at Houston, Texas in 1974.

The Portland Commission attended all of the meetings at this convention.

Jim Rondeau appointed a Medical Committee with Dr. Battalia of Portland as chairman with a delegate from Mexico, Hawaii, Washington and California with the idea of forming a standard medical form for boxing.

It was reported that the W. B. A. Convention had been changed from Caracas to Puerto Rico and the date changed to Aug. 19 - 22, 1973.

The chairman told of the bill before the legislature in regards to the distributing of the surplus funds from the boxing and wrestling shows had been passed by the House and had gone on to the Senate. At the present time it had not come out of committee and he was watching to see when any hearings were up on this matter.

A letter from Tex Hager of Eugene requesting a matchmakers license was read and Mr. Hager was introduced to those present. Dr. Battalia asked Mr. Hager to give the Commission an outline of the program he had in mind. Mr. Hager stated that he had a few fighters that would fight in programs of his in Portland but he did not want to create any problems with Mr. Singer and he would cooperate with him in every way. He also explained that if it was agreeable with Mr. Singer, he would go along with putting on a fight every other month.

A discussion followed in regards to a various number of boxers and the types of bouts put on.

Don C_asciato asked the commission to consider the fact that they have not had a sufficient amount of fights to please the Commission was because of the lack of effort on the part of Mr. Singer or the matter of the lack of availability of fighters. He further stated that the Commission should consider, No. 1--is there any good reason for not having enough fights and No. 2--is there room for two promoters.

Dr. Battalia stated that in view of the number of shows in the past two years and that with only two fights so far this year, he felt that some action ~~was~~ certainly needed. All the members agreed that all events, no matter what, needed to be put on with more regularity.

Sam Singer then announced that he was negotiating with a manager to bring in 11 fighters into Portland but if the Commission was to split the shows, he would scrap this project. He also promised that between now and January 1, 1974 he would have five more fights.

The chairman told Mr. Hager that to be eligible for a license he would have to put up a \$5000.00 bond to protect the city and the Commission from bills he would incur. Mr. Hager agreed to this and stated that he would have no objections in working with Mr. Singer on one fight a month for each matchmaker. Other discussions followed on boxers and matchmakers working together. The chair asked the Commission if they wanted to grant Mr. Hager his license or table or deny it. In view of the fact that Mr. Singer was negotiating to bring a stable of 11 fighters to Portland in two weeks, Mutt Cosentini made a motion to table this matter for further consideration from the Commission. He further stated that this Commission was primarily interested in giving the paying public the best shows and if it takes two matchmakers to do this, then the Commission should act accordingly.

Abe Tanzman requested that since the Commission felt there was room for more than one matchmaker, his request be considered. The chairman informed him that his previous letter had already been acted upon and it would be necessary for him to make another written request. Sam Singer then told the Commission rather than tabling Mr. Hager's request to give him a license and Three Star Sports would request four shows a year. Mutt Cosentini stated that we would carry out our motion. Dr. Wilhelmi also stated that he would like to consider this matter more. Motion was called for and seconded by Dr. Wilhelmi. Motion carried.

The following card was presented for sanctioning by Three Star Sports for the night of June 28, 1973:

Dr. Battalia made a motion to sanction this card. Seconded by Mutt Cosentini. Motion carried unanimously and Sam Singer was complimented on the good fight shows he put on in this city.

PORTLAND MUNICIPAL BOXING AND WRESTLING COMMISSION

MINUTES - JULY 23, 1973

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman, Nick Sckavone, on July 23, 1973, at 7:00 P. M. in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Those present were Nick Sckavone, Dr. Jack Battalia, Dr. Ken Wilhelmi, Mutt Cosentini, Don Casciato, Tex Hager, Walt Yeager, George Yerkovich, Abe Tanzman, Sam Singer and Harvey Isaacs.

The minutes of June 25th were read and corrections noted and made. Mutt Cosentini made a motion that the minutes be accepted as corrected. Seconded by Don Casciato. Motion carried.

The receipts and disbursements for the month of June were read. A motion was made by Mutt Cosentini to accept the statement as presented. Seconded by Don Casciato.

The subject of having the annual audit of the commission books by a CPA was brought up. Dr. Battalia made a motion that this be done as usual. Seconded by Dr. Wilhelmi. Motion carried.

The chairman then reported that a draft of the Rules and Regulations of the Boxing Commission had been made and read by all the Commissioners. There had been no changes except a few minor ones by Walter Yeager from the City Attorney's office. One change was the deletion of the \$25.00 fee for a matchmaker as the commission appoints the matchmaker, therefore he does not have to have a license as noted.

Section 9 Par. B was then discussed. Dr. Battalia suggested that an amendment providing a minimum of four (4) bouts per year be added to that part providing for a \$1,000.00 performance bond or cash or security, approved by the Commission, be posted by the matchmaker for each boxing show he purports or represents to the commission that he is capable of staging during the term of his appointment. The performance bond or equivalent will be forfeited for failure of the matchmaker to stage competitions as represented to the commission. Dr. Battalia made a motion that this amendment be accepted. Seconded by Dr. Wilhelmi. Motion carried.

Dr. Battalia made a motion that this draft of Rules and Regulations as editorially corrected by Walter Yeager be adopted as the official rules and regulations of the Portland Municipal Boxing and Wrestling Commission. Seconded by Mutt Cosentini. Motion carried. The Executive Secretary was instructed to have these rules put in book form.

Nick Sckavone then told the matchmakers that the commission had been very lax in regards to the rules for main event contracts. Nick stated that main eventers must have their contracts in five (5) days before the match goes on. A signed telegram would be sufficient. Therefore, main event contracts should be in the hands of the secretary by Monday before a Thursday fight.

July 23, 1973

The tabled application of Mr. Tex Hager was presented for further consideration. Dr. Battalia made a motion that the application be so moved from the table. Seconded by Mutt Cosentini. Motion carried. Tex Hager was then asked if he would like to change his letter to agree with the commission ruling of at least four (4) bouts a year. He agreed and that it could possibly be more. Dr. Battalia made a motion that Tex Hager be appointed as our second matchmaker. Seconded by Dr. Wilhelmi. Motion carried.

The chairman stated that Sam Singer of Three Star Sports had requested the date of August 23, 1973 for a match. However, Sam Singer stated that he would like to withdraw that date and take one around the middle of September on a Thursday. The commission then stated that the two matchmakers should be able to work together on the dates for succeeding fights.

The WBA Convention in Puerto Rico on August 19th was discussed and it was suggested that Dr. Battalia and Mutt Cosentini be sent to represent this commission. The Executive Secretary to make the necessary arrangements.

There being no further business the meeting was adjourned.

MINUTES - SEPTEMBER 24, 1973

Meeting of the Portland Municipal Boxing and Wrestling Commission was called to order by Chairman Nick Sckavone on September 24, 1973 at 7:30 P. M. in the Woodmen Building, 1847 S. E. Clinton, Portland, Oregon. Those present were Don Casciato; Mutt Cosentini; Dr. Ken Wilhelmi; Dr. Jack Battalia; Paul Weitzel; Dr. Lorey; Bob Hyle; Harvey Isaac; Sam Singer; George Yerkovich; Jerry Dusenberry and John Nolan.

On a motion by Dr. Wilhelmi the minutes of July 23, 1973, were accepted as read. Seconded by Mutt Cosentini. Motion carried.

Don Casciato made a motion that the statement of the receipts and disbursements for the month of July be accepted. Seconded by Ken Wilhelmi. Motion carried. The statement of receipts and disbursements for the month of August were accepted by a motion made by Don Casciato and seconded by Dr. Battalia.

Nick Sckavone told of the annual audit having been made and a copy of which had been given to each commissioner.

The chairman remarked that the revised rules had now been put into book form and commended the commission for such a fine job. He also thanked Mr. Yeager of the City Attorneys office for helping with the legal language in the book. It was suggested that all managers coming into town be given a book of the rules.

Mutt Cosentini and Dr. J. Battalia were thanked for attending the WBA Convention in Puerto Rico and for doing such an outstanding job in representing the Portland Commission. Mutt Cosentini reported that Bill Miller of the Rating Committee gave an outstanding report and also stated there had been a discussion in regards to the commissions protecting their matchmakers on the TV rights. It was pointed out that most of the commissions are collecting their percentages from the TV gates. Dr. Battalia stated this gave the local matchmakers a chance to make something and if he wanted to, to put on a live preliminary card before the TV program. The chairman suggested that this would be something for the commission to think about and go down in a body to the State Legislature. George Yerkovich mentioned that the city had a lobbyist in Salem. Mutt also mentioned of a computerized scoring system which was quite involved and expensive.

Dr. Battalia told of a demonstration of a round ring which he felt would really be something and the cost not too bad. He further stated that we could get a movie showing this ring in action. Nick Sckavone suggested that Dr. Battalia write and get this film from Dean Smith and perhaps show it at our next meeting.

Mutt Cosentini stated that Nick Sckavone had been elected as President of the National Wrestling Association.

Nick Sckavone asked George Yerkovich to report on the recent N.A.B.F Executive Meeting in California. George told of their trying to

to get a uniform medical card for all fighters. Dr. Jack Battalia is the chairman of this committee. Dr. Battalia stated that this form could be a little involved but he felt that it could be done. George stated that the committee was talking of getting a card for each boxer showing the dates he had fought and the matchmaker when he pays off would initial the card with the date of the match. George then told of the various championship fights which are going on and that they had written to Dooley of New York about this situation. He read a letter from the N. A. B. F. to Mr. Dooley which had been put on file with the commission.

Dr. Battalia reported that at the convention a United States Rating was discussed. Along with the WBA rating and the NABF rating he felt there would be conflict. Although there had been some protest, he was afraid it was going through.

Nick Scavone explained the switch in dates for the coming boxing shows. He had talked with Tex Hager and it was agreeable with him that Sam Singer have the date of Oct. 4, 1973 and Tex Hager would have the date of Nov. 1, 1973. Sam Singer was going with Al Bolden and Tex Hager was going with "Sugar" Seales.
