AMENDMENT No. 2 to

Grant Agreement for Community Health Assess and Treat (CHAT)

Between

CareOregon, Inc.

and

The City of Portland Grant No. 32002585

This Amendment No. 2 amends Grant No. 32002585 dated January 15, 2022 by and between CareOregon, Inc. (CareOregon) a domestic nonprofit corporation registered in the State of Oregon, and the City of Portland, a municipal corporation of the State of Oregon ("City") by and through their duly authorized representatives. This Amendment may refer to CareOregon and City individually as a "Party" or collectively as the "Parties."

This Amendment is authorized by City Ordinance No. 190578.

The Effective Date of this Amendment is October 1, 2022. The purpose of this Amendment is to extend the termination date, add funds and revise provisions.

The Grant Agreement was previously amended as follows:

Amendment 1, dated October 1, 2021, which extended the duration of the Grant Agreement and added provisions.

The Parties agree to Amend the Grant Agreement as follows:

- 1. The Term is extended from October 1, 2022 to September 30, 2023, unless terminated sooner under the provisions of the Grant.
- 2. The Grant Agreement not-to-exceed amount of \$ 2,488,575 is increased by \$2,400,000 to a new total not-to-exceed amount of \$4,888,575.
- 3. Attachment A-1: Budget, is replaced with the attached Attachment A-1: Budget 2023.
- 4. Attachment B-1: Quarterly Report Supplement is replaced with the attached Attachment B-1: 2023 Quarterly Report Template.



- 5. Attachment C: Data Sharing is hereby added in its entirety to this Agreement.
- 6. Exhibit 1 CareOregon Correspondence is added.
- 7. The Project Manager is changed from Lisa Reslock to The Community Health Services Director.

All other terms and conditions of the Grant remain unchanged by this Amendment and in full force and effect.

This Amendment 2 to Grant No. 32002585 and Exhibit 1: CareOregon Correspondence, when taken together shall constitute one and the same grant amendment.
