AMENDMENT NO. 1 Subrecipient Contract No. 32002786

The above referenced Subrecipient Contract between the City of Portland (City), acting by and through its Portland Housing Bureau (PHB), and African American Alliance for Homeownership, hereafter called "Subrecipient," is hereby amended as follows:

Amend Paragraph 4, Compensation as follows:

4. Compensation

The amount of compensation shall not exceed ~~\$99,000~~ **\$120,000** in Community Development Block Grant (CDBG) funds. The compensation requirements are contained in Section I. The **final invoice is due July 5, 2023.**

Amend Section I, paragraph E as follows:

I. Compensation and Method of Payment

E. Total compensation under this contract shall not exceed ~~NINETY-NINE THOUSAND DOLLARS (\$99,000)~~ **ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000)**
