Mayor Wheeler and Commissioners,

I am writing in opposition to Agenda Items reference above. Cryptosporidium is the issue, it is not required to build a \$1.9 Billion Industrial Filtration Plant. UV will clean the Cryptosporidium and is all that is required by the EPA, and Oregon Health Authority. This Proposed Industrial Filtration Plant is a Portland Water Bureau, State of the Art Ego Boost -at the cost of the ratepayers, and wholesale customers.

We are in times of inflation, with high cost of utility bill, food, housing, gas, constructions, goods and services. Which is concerning for low income and middle class. Homelessness is on the rise. I heard on the news that over 50 years of age is a large portion of the homeless population in our Country. I read an article that Mayor Wheeler was concerned about the increase in utility rates. Commissioner Mapps stated in a TownHall, his "Goal Is To Keep Utility Rates Flat". Building a \$1.9 Billion Filtration Plant does not achieve Commissioner Mapps goal, or address Mayor Wheeler concerns!

I do understand PWB is concerned about turbidity, earthquakes, and forest fires. Dave Peters was asked by Fire District 10, "how many fires have been in the Bull Run? Mr. Peters, answer was "None"! We all know that if a forest fire was in the Bull Run it would be put out quickly. Earthquake, the infrastructure of the PWB pipelines in Portland would not hold up. I had a discussion with Amanda Fritz on Earthquakes, and the infrastructure within the pipes. She stated that is on the docket to be fixed. Where is that money coming from? Ratepayers, and Wholesale Customers? PWB Budget Office Financial Impact Analysis states, "funding this project will not affect rate increased above what has been already communicated. PWB is vague on what the rates will do to the general public! Two of the Wholesale Customers anticipate a 800% increase over the next 10 years. One of the Wholesale Customers is drilling their own wells. Gresham is also sourcing their own water, dropping out as a Wholesale Customer. When Wholesale Customers leave, who picks up the burden of the cost?!

PWB has a record of going over budget, wasting money, and failed projects. I remember watching a City Council Meeting where Mike Stuhr and Dave Peter said the proposed project was \$350,000,000 to \$500,000,000. Later to find out that they forgot the Pipelines. This is typical PWB shenanigans. This Proposed Project is currently estimated to go over \$1.9 Billion. That does not include fixing all the East Multnomah County and Clackamas County Roads after construction and the condition from both Counties.

*Please take a look at page 5 of the Annual Report and do the math on the Estimated Totals- $\$1,069\text{M} + \$404\text{M} = \$1,073\text{M}$. Not $\$1,083\text{M}$. Is this a typo error or can someone not add. Regardless of either- It is sloppy of PWB to give this to you and to send it out in a mass email. "What possibly could go wrong with this propose project?"

It is time as Mayor and Commissions to put a Stop to PWB's Gaslighting and Irresponsible Spending!"
