As authorized by City Ordinance 179683, and ORS 190.010, this Intergovernmental Agreement (“Agreement”) amendment is entered into on June 1, 2021, by and between the City of Portland, a municipal corporation of the State of Oregon, hereinafter referred to as “City” and Portland State University through its Center for Executive and Professional Development, hereinafter referred to as “PSU.” This Agreement may refer to the City and PSU individually as a “Party” or jointly as the “Parties.”

1. The purpose of this amendment is to extend the term and add additional services.
2. This Agreement is hereby extended through **June 30, 2026**.
3. The Scope of Work is hereby updated with new language added in **BOLD and underline**.

Original Scope of Work

SECTION 3 PRICING, INVOICING AND CHANGES

3.1 Pricing. Total investment in classroom and virtual training is \$100,000.00 each fiscal year (not to exceed a total amount of \$300,000.00 over the 3-year life of this Agreement). Pricing to be at the following rates, based on instructor or consultant selection:

- 3.1.1 Training delivery from \$400 - \$475 per hour.
 - 3.1.2 Consultative services from \$200 - \$400 per hour.
 - 3.1.3 Curriculum and course content development from \$100 - \$400 per hour.
 - 3.1.4 Participant material costs as identified.
- 3.2 Invoicing:
- 3.2.1 **The City will be invoiced at the completion of each training.**
 - 3.2.2 Payment is due within thirty (30) calendar days from invoice date.
 - 3.2.3 A 3% charge may be added if payments are not made within the allotted timeframes..

4. All other terms and conditions shall remain unchanged and in full force and effect.
