Emergency Ordinance

*Accept and appropriate \$9,750,000 from Multnomah County and authorize Intergovernmental Agreement for affordable housing development and acquisition

Passed

The City of Portland ordains:

Section 1. The Council finds:

- The Portland Housing Bureau ("PHB") is charged with implementing the housing policies of the City of Portland ("City") under City Council Ordinance No. 182465 including the Local Implementation Strategy for the Metro Bond approved by City Council Ordinance No. 190095 on August 12, 2020.
- 2. On behalf of the City of Portland, the Portland Housing Bureau ("PHB") administers affordable housing programs using various local funding sources, including City, County, Metro, state and federal funds to support the development and acquisition of affordable housing.
- 3. PHB announced the 2023 Metro Bond Opportunity solicitation to help close funding gaps for projects with affordable housing, dedicating \$10,000,000 in Metro Bonds plus an additional \$9,088,000 in Metro interest earnings for permanent support housing.
- 4. To increase the scale and speed of PHB's housing development and acquisition, Multnomah County proposes to allocate \$9,750,000 of general fund dollars from its fiscal year (FY) 2024 budget to PHB under an intergovernmental agreement in form and substance of attached Exhibit A.
- 5. This Multnomah County funding source should be appropriated into the Grants fund as a nonfederal grant.

- A. The Commissioner-in-Charge is hereby authorized to accept and appropriate \$9,750,000 from Multnomah County General Funds for the purpose of funding the development and acquisition of affordable housing.
- B. The Commissioner-in-Charge or the Portland Housing Bureau Interim Director is hereby authorized to enter into an intergovernmental agreement with the County, substantially in accordance with the agreement attached as Exhibit A. The Portland Housing Bureau Interim Director is also hereby delegated the authority to modify, by amendment, provided such modifications do not increase the City of Portland's financial obligation or risk.
- C. The City is hereby authorized to receive payments in the amount of \$9,750,000 from the County.
- D. The FY2023/2024 budget is hereby amended as follows:
 GENERAL FUNDS
 Fund 217
 Business area HC00
 Bureau Program Expenses \$9,750,00

Section 2. The Council declares that an emergency exists in order to avoid delays in the provision of affordable housing during an ongoing housing crisis in the State of Oregon and the City of Portland; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.

Impact Statement

Purpose of Proposed Legislation and Background Information

- Many multifamily residential projects, including some affordable housing projects, have been stalled due to cost increases and/or interest rate increases and are now facing funding gaps.
- In order to assist these projects to financial close, PHB announced the 2023 Metro Bond Opportunity solicitation to help close funding gaps for projects with affordable housing, dedicating \$10,000,000 in Metro Bonds plus an additional \$9,088,000 in Metro interest earnings for permanent supportive housing.
- To increase the scale and speed of PHB's housing development and acquisition, Multnomah County proposes to allocate \$9,750,000 of general fund dollars from its fiscal year (FY) 2024 budget to PHB under an intergovernmental agreement in form and substance of attached Exhibit A.
- The purpose of this ordinance is to accept the \$9,750,00 in Multnomah County funds to the Portland Housing Bureau through December 31, 2024 for affordable housing and acquisitions.

Financial and Budgetary Impacts

Community Impacts and Community Involvement

Throughout 2023, the Housing Bureau has heard from developers for both affordable housing and market rate housing that many multifamily residential projects have been stalled due to cost increases and/or interest rate increases such that their projects are now facing funding gaps. This market feedback has been further demonstrated by the drop in building permit submittals to Bureau of Development Services. In addition, the Housing Bureau has been approached by owners intent on selling their multifamily projects that are reaching completion or of recent construction at a substantially lower price than all-in costs of building new. Many of these existing buildings have construction loans that are maturing and refinancing are difficult under current market conditions.

In order to assist projects in the pipeline reach financial close, PHB announced the 2023 Metro Bond Opportunity solicitation to help close funding gaps for projects with affordable housing. With Multnomah County funds, there is the additional possibility of increasing the scale and speed of PHB's affordable housing stock especially through acquisition.

100% Renewable Goal

Portland Clean Energy Fund (PCEF) funds for clean energy improvements are being offered for projects which can benefit from these County funds under the 2023 Metro Bond Opportunity Solicitation for last gap.
