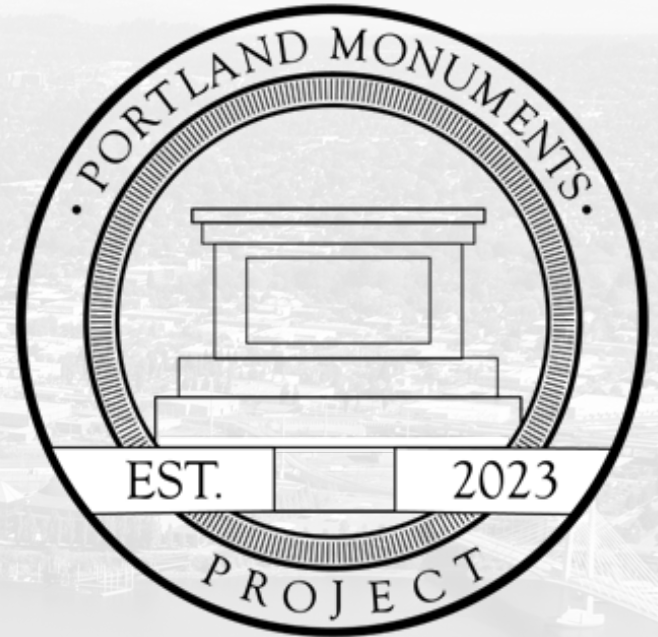

What do Portlanders think about the current collection of monuments in the City's Public Art Collection?



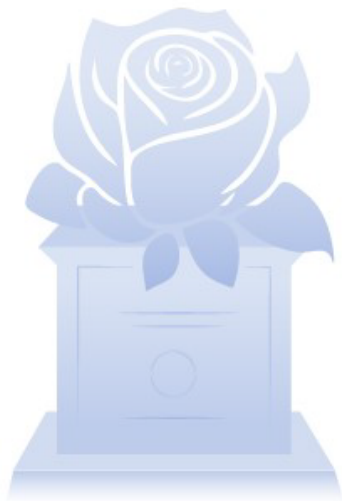
What principles and practices should guide the City's decisions about monuments and modifications to public art for new interpretations of history and enhancing public education about the monuments in the City's Public Art Collection?

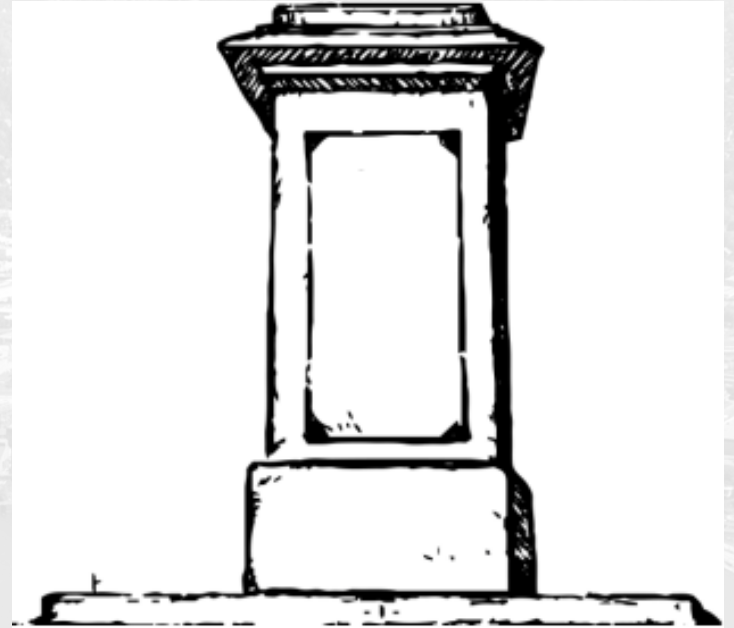

5.74.085 PUBLIC MONUMENTS REVIEW POLICY OVERVIEW

- Establishes public complaint process for City of Portland-owned monuments
- Defines Public Monument Review Criteria
- Designates City Arts Program as responsible for responding to Complaints
- Defines Public Monument in City Code
