A letter was then read by the Secretary from Chief of Police Niles thanking the Reserves for their services at the Annual Inspection and Exhibition of the Police Dept, and also for their services during the Rose Festival.

Capt Tichenor then advised the members that it was the intention to increase the membership of the Reserves to two hundred men, and advised the members that if they knew of any good men for membership to bring in their applications.

Capt Tichenor then called on Advisor Goldstein who made a very fine and timely talk on our National emergency and preparedness. This talk was enjoyed by all present.

Reserve Officer then spoke regarding members of the Reserve who might be drafted in the service of our Country, He was advised by Capt Tichenor that if any member of the Reserve was drafted he would immediately turn in his Star and credentials, and upon his return from service would be given preference over all other applicants for membership.

There being no further business the meeting was adjourned
