Planning & Sustainability Commission (PSC) history

- Planning & Sustainability Commission established 2010
- PSC balancing state mandated roles & climate action/sustainability
- Planning Commission established Feb. 2023 via Ordinance No. 191150
 Directed BPS to bring Sustainability or Climate Commission proposal to Council
- New Sustainability and Climate Commission (SCC)
 - resets scope, expectations, and establishes action on climate & sustainability



City's climate action – Climate Emergency Workplan (CEW)

- City Council declared a climate emergency in 2020
- Climate Emergency Workplan approved July 2022
- Sustainability and Climate Commission (SCC)
 - A key accountability body on climate and sustainability for community, other governance bodies & City of Portland

Charter Reform – Charter Commission review

- Phase I passed in November 2022 by voters as Ballot Measure 26-228
 - Mayor and City Administrator responsibilities:

"Advance the City's efforts to mitigate the human-made climate crisis and prioritize environmental justice initiatives."





Goals

- Reset the scope, expectations, and establish a new authority on climate and sustainability
- Create accountability for City and its service areas, and the Portland community
- Create the City's Climate Action Plan and other guiding documents on climate
- Advance the city's efforts to mitigate the human made climate crisis and prioritize environmental justice initiatives
- Ensure the City is on track to meet established climate goals
- Balance advisory, advocacy, & action in its charge





Structure

- 20 members + 6 City staff liasions members
 - Community members
 - Youth commissioners
 - Six City staff liaisons as non-voting members
 - Deputy City Administrators (DCAs) or their designee
- Organized by focus areas
 - Members recruited in areas of expertise/knowledge

SCC focus areas

- Building and homes
- Climate change resiliency and adaptation
- Energy and renewables
- Environmental justice and equity
- Urban forest, natural systems, and carbon management
- Urban form and transportation
- Waste prevention, recycling, and solid waste
- Youth





Functions and plans

- City Administrator-level commission
- Balance advisory, advocacy, & action
- Collaborate with other advisory bodies
- Accountability and transparency





Engaging with SCC

Tier I – LEARN & PLAN

Staff makes decisions with SCC validation, updates and educates SCC. Examples of actions include:

- DCAs, or their designee, briefing SCC on implementation strategy of previous agreed upon workplans from service areas
- 。 accepting progress reports
- o holding joint meetings with other committees



Tier II – CREATE & EVALUATE

DCAs, or their designee, work with the Chief Sustainability Officer to bring forward proposals for SCC recommendations, refinements, and alignment with established climate goals

- Decision making authority is ultimately with City Council, the Mayor, and the City Administrator, however, SCC recommendations will strongly inform decisions
- Gives public forum for debate on the issues at the SCC
- Addresses the charter reform charge for the City Administrator and the Mayor to address the human-made climate crisis



Tier III – ACT

The Chief Sustainability Officer works with Deputy City Administrators and their offices to bring work from SCC to City Council, the Mayor, and the City Administrator for final action and decision making.

- 。Gives public forum for debate on the issues at the SCC
- End goal is defined (*i.e.*, ordinance, resolution, report)



Accountability

- Public transparency with information exchange
- Publicly accessible with clear communication & public comment opportunities
- Follow-up on actions, concepts, recommendations
- Evaluation of past and current programs, policies, and projects



How commissioners will be appointed*

- Apply via City's Advisory Bodies Program
- Review by SCC Coordinator and other staff
- Chief Sustainability Officer for recommendations
- Recommendations to the Mayor for appointment
- Appointments to City Council for approval
- Applications will be reviewed and chosen with focus areas in mind

*Subject to City's Advisory Bodies Program requirements



Next steps

- Second reading in May:
 - Approve Agenda Item 338: Create the Sustainability and Climate Commission (amend Code Chapter 3.33) Ordinance
- Anticipated recruitment starting Fall 2024 pending guidance from City advisory bodies
- Commissioners seated anticipated Winter 2025
