ORDINANCE No. 137642

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals for furnishing materials, equipment and labor and for installing the Irving Park Street Lighting Project (LEAA Grant) for the Bureau of Lighting, authorizing a contract therefor, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Purchasing Agent hereby is authorized and directed to advertise and receive proposals for furnishing materials, equipment and labor and for installing the Irving Park Street Lighting Project (LEAA Grant) for the Bureau of Lighting, Department of Public Works, in accordance with the plans and specifications therefor filed in the Bureau of Purchases on December 4, 1973, and amended December 7, 1973, with respect to addition of special provisions pertaining to LEAA Grant projects by way of addendum, which plans, specifications and addendum hereby are adopted and by this reference made a part of this ordinance.

Section 2. The Mayor and the Commissioner of Public Works hereby are authorized to enter into a contract with the responsible bidder submitting the most advantageous bid for the project mentioned in Section 1 hereof. The Council hereby reserves the right to reject any and/or all bids, in whole or in part, and in the event that no satisfactory bid is received, the Purchasing Agent hereby is authorized to readvertise therefor on the same basic specifications as amended and plans until a satisfactory bid is received. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1973-74 Budget, Street Lighting Fund, Bureau of Lighting, Improvements (332.730*), when demand is presented, approved by the proper authorities.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that there may be no delay in providing authority for the contract for the project described hereinabove based on the specifications and plans, with addendum, as hereinabove adopted, this ordinance should be effective immediately upon its passage; therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
