Dear Mayor Wheeler and City Commissioners,

My name is Sarah Radcliffe and I am the Director of Government Relations for Habitat for Humanity Portland Region. I'm here today to testify on behalf of Habitat Portland Region as well as Proud Ground, the Northwest Region's largest Community Land Trust, Portland Community Reinvestment Initiatives (PCRI), a Black-led affordable housing developer serving Portland communities for over 30 years, and Housing Oregon, a coalition of affordable housing developers and advocates.

Together, we are requesting that affordable housing developments be exempted from increased permitting fees. *Ideally, our programs and our future tenants and homebuyers would benefit greatly from a full or partial waiver of permit fees.*

Prior to November 2023, affordable housing developers could access waivers or partial exemptions from permitting fees. We need the City's partnership now more than ever.

Construction costs have increased substantially since the pandemic and consequently, it is more and more challenging to build the affordable housing that our communities so desperately need. We've seen the cost of land, materials, and labor rise 50-60% in just the past ten years. As affordable housing developers, it's not an option to simply pass these costs along to our tenants and homebuyers.
