Mayor Wheeler and Members of City Council:

The Northeast Broadway Business Association (NEBBA) represents the interests of businesses and property owners on NE Broadway and Weidler Streets between NE 3rd Ave. and 37th Avenue. Our business district is a major transportation hub, filled with small local businesses that provide an expansive array of shops, services and restaurants, in addition to larger-scale companies and services. It serves a diverse community within the City, as its location includes affordable and transitional housing, apartment complexes, and historical houses.

Despite these underpinnings, Northeast Broadway has struggled to obtain the street appeal of successful commercial areas in Northeast Portland, like Alberta and Mississippi.
