Dear Mayor Wheeler and Portland City Commissioners,

I am writing on behalf of HereTogether, a coalition of service providers, business leaders, and local experts dedicated to solving the homelessness crisis in the Portland region. We have closely reviewed the final Homelessness Response Action Plan (HRAP) and are encouraged by the incorporation of many of our recommendations. The plan reflects the community's input and commitment to addressing this critical issue.

We also want to voice our support for the Homelessness Response System Intergovernmental Agreement (HRS IGA). This agreement provides the legal framework and commitments necessary to implement the strategies and achieve the goals in the final HRAP. The alignment between these two documents demonstrates a unified approach to addressing homelessness in Multnomah County.

We commend the emphasis on collaboration through the establishment of a comprehensive governance structure, the focus on prevention with clear, actionable goals, and the commitment to continuous improvement and data-driven decision-making. These elements are crucial to the plan's success and demonstrate a proactive approach to tackling homelessness.

However, we must stress the urgent need for concrete action regarding fair compensation for service workers and contract reforms for nonprofit providers. While the HRAP acknowledges the importance of this issue, there is no sense of urgency. The time to act is now. The current system has several glaring flaws:

- 1. Unequal pay: Nonprofits are compensated differently for identical work. This blatant injustice demands swift correction.
- 2. Delayed reimbursement: Nonprofits often must underwrite the cost of delivering services, as reimbursement can take months.

In addition to addressing these issues, the final HRAP commits to adopting a continuous quality improvement (CQI) framework to drive enhanced performance and system transformation. This is a critical step, as a proven CQI framework will be essential for delivering improved operational performance and ensuring the plan remains dynamic and responsive to emerging needs and challenges. However, CQI must become an overarching strategy, not just a side project, to be truly effective. Elected officials and agency leaders must prioritize adopting this framework, training

personnel, and making continuous improvement an integral part of their operational playbook. Robust data and analytics will enable measuring progress and making timely adjustments. We strongly advocate that our region's leadership follow through on this CQI commitment. Doing so will be essential for meaningfully improving service delivery, driving system transformation, and achieving the plan's goals of reducing homelessness in our community.

The final HRAP represents a significant step forward in addressing homelessness in our community. The near-term goals, such as ending homelessness for youth aging out of foster care by 2027 and preventing discharges from hospitals and corrections to the streets by 2025 and 2026, among others, are ambitious but achievable. We appreciate the incorporation of our feedback and look forward to continued collaboration to ensure the plan's success.

As a community coalition-based watchdog, HereTogether will actively monitor the progress of these goals and provide regular updates to keep our coalition members and the public informed and engaged. We believe that everyone has a role to play in achieving these objectives and working toward a future where homelessness is rare and brief.

We urge you to adopt the final Homelessness Response Action Plan and the Homelessness Response System Intergovernmental Agreement, prioritize the implementation of fair compensation for service workers, and ensure the successful operationalization of the CQI framework. Together, we can significantly impact the lives of those experiencing homelessness in our community.

Thank you for your commitment to addressing this critical issue.

## Testimony of Eric Fruits, Ph.D.

Submitted to Portland City Council June 19, 2023

## Re: Agenda Item 546 Authorize Three-Year Homelessness Response System Intergovernmental Agreement with Multnomah County

I am a Portland resident, business owner, and nonprofit board member. <u>I urge you to</u> <u>vote note "no" on adopting the proposed Intergovernmental Agreement</u> between Multnomah County and the City of Portland ("2024 IGA") governing the Joint Office of Homeless Services.

After carefully reviewing the existing 2016 Intergovernmental Agreement ("2016 IGA") and the 2024 IGA, I believe the new agreement is not in the city's and its residents' best interests.

#### The City loses nearly all of its bargaining power under the 2024 IGA

The 2024 IGA is a radical departure from the 2016 IGA. While the current IGA reflects a rough balance of power between the City and the County, the proposed 2024 IGA is almost entirely one-sided in favor of Multnomah County at the expense of the City, its voters, and its taxpayers.

- **Indemnification**: The 2016 IGA had mutual indemnification clauses where each party indemnified and held the other harmless. The 2024 IGA adds a new clause where both parties indemnify Metro, but the mutual indemnification between the City and County appears to have been removed. This puts more liability risk on the City.
- **Termination**: The 2016 IGA allowed either party to unilaterally terminate with 60 days notice with a "break-up" fee of only \$250,000. The 2024 IGA requires 90 days notice and obligates the terminating party to pay wind-down costs if they terminate because they failed to meet baseline funding. This penalizes the City more if it needs to terminate due to inability to fund at the required level. Even worse, the 2024 IGA obligates the City to take back and fund certain homeless service programs upon termination without a reciprocal obligation on the County. This locks the City into funding these programs even post-termination.

## No accountability under the 2024 IGA

More concerning is that the 2024 IGA does not include sufficient new accountability measures to improve the Joint Office's historically poor performance in reducing homelessness. While both agreements have reporting requirements and performance metrics, the 2024 IGA adds no new enforcement mechanisms or penalties if the Joint Office fails to meet its goals.

The proposed governance structure centers around advisory committees without real decision-making authority to drive needed changes if the Joint Office underperforms. Improved data collection requirements are a step in the right direction for assessing performance, but there are no provisions empowering the City to audit or investigate the Joint Office's activities. Only the County auditor has that ability. And, to make matters worse, the Multnomah County Commission has a history of subverting the County Auditor's Office from doing its job.

The 2024 IGA puts the City in a worse position—accepting more downside risk in terms of potential liability and obligations, without gaining any meaningful new control or oversight over the Joint Office's outcomes. The structural changes are unlikely to move the needle on performance without real enforcement teeth behind them.

#### No acknowledgment of the City's obligations under its ADA case settlement

Last year, the City settled a lawsuit, *Tozer v. City of Portland*, filed by several disabled residents regarding homeless camps and debris denying residents access to public sidewalks. The lawsuit resulted in a settlement agreement with the City and now provides benefits for our neighbors with disabilities who can now navigate many city sidewalks. Since the settlement, many sidewalks have noticeably improved accessibility for all residents.

Nevertheless, the County's policy of widespread distribution of tents and tarps has frustrated the City's attempts to abide by its obligations under the settlement. In testimony before City Council, John DiLorenzo reported, "Since our settlement agreement last June, the Joint Office has distributed another 6,554 tents and 24,172 tarps. Certain groups and direct recipients have, in turn, placed these tents and tarps back on our sidewalks and neighborhood streets where the clean-up cycle repeats and millions more dollars are expended."

Under the terms of the 2024 IGA, the City will be obligated to fund the Joint Office, which will use some of that money to buy and distribute tents and tarps, only for the City to expend more funds to clear the tents and tarps from public sidewalks. At a

minimum, the 2024 IGA should require the County to pay its fair share of the cost of cleaning up the mess associated with its tent-and-tarp distribution policies.

Given the Joint Office's long history of underperformance in the face of our homelessness crisis, the City Council should demand an agreement that provides more balance between the parties and critically, real accountability for outcomes. Until that is achieved, **I strongly encourage you to vote "no" on adopting the 2024 IGA** in its current form.

Ideally, **the City should sever its relationship with the Joint Office altogether** and use the \$42 million it pays each year to the Joint Office to provide a more compassionate response—sheltering people rather than allowing them to languish on the streets.

Portland and its residents deserve better.
