#### SECTION 4: First Aid Measures

#### 4.1 Description of first aid measures

#### 12.2 Persistence and degradability:

Metaldehyde is of low persistence in the soil environment, with a half-life on the order of several days]. It is weakly sorbed by soil organic matter and clay particles, and is soluble in water. Due to its low persistence, it is not a significant risk to groundwater.

#### 12.3 Bioaccumulative potential:

The product adsorbs to soil but shows little or no tendency to bioaccumulate.

#### 12.4 Mobility in soil:

The product is adsorbed on soil and is unlikely to leach into water sources.
