1. Independent Police Review (IPR) Work Plan / Accomplishments

2016 CRC Recruitment Outreach

IPR Community Outreach Coordinator Irene Konev met with several community leaders to promote the CRC volunteer recruitment, the Iraqi Society of Oregon, Central City Concern, Ahishta Turkish Community Center, Urban League, and Crime Victims Advocacy Program. She promoted it at the Community and Police Relations Committee and Race Talks. IPR staff made presentations to IRCO Refugee and Immigrant Family Strengthening Program, Human Solutions, and IPR director Constantin Severe spoke on KBOO Radio to promote the CRC recruitment, and bring greater awareness of IPR. Ads have been placed in several newspapers including the Asian Reporter, The Skanner, The Portland Observer, El Hispanic News as well as the Office of Neighborhood newspapers and newsletters.

IPR is holding a CRC volunteer recruitment information session on May 17^{th} from 5:30 to 7:00 pm in the Auditor's Conference Room. The CRC application is found on the IPR website. The application deadline is in June 2^{nd} , at 5:00 pm.
