#### **Director's Report**

## 1. Independent Police Review (IPR) Work Plan / Accomplishments

#### Interim Director Amanda Lamb Appointed

Auditor Mary Hull Caballero has appointed Amanda Lamb to serve as IPR's Interim Director during the IPR leadership transition following the departure of former Director Constantin Severe. Interim Director Lamb has been with the Auditor's Office since 2018 and previously served as Chief Deputy Auditor. A national search for a permanent IPR director is currently underway.

#### **Department of Justice**

The Department of Justice is in town the week of June 3 to discuss progress toward compliance on the settlement agreement. IPR is participating in meetings related to Section 8 – Office Accountability. Meeting participants have discussed the drivers (causes) of cases going over 180-days with regard to both Internal Affairs and IPR investigations, and strategies to address those drivers.

#### 2018 Annual Report Released in April

This was IPR's 16<sup>th</sup> annual report to the public and provides an overview of the people and processes involved in Portland's police accountability system. The report is available on IPR's website along with interactive data dashboards with downloadable data.

#### **IPR Director Recruitment**

The recruitment for the IPR Director is currently underway. Prior to the release of the job announcement, then-Chief Deputy Lamb met with a variety of internal and external stakeholders to build a candidate profile for the new Director. Those stakeholders included representatives from the Citizen Review Committee, the Portland Committee on Community-Engaged Policing, the Office of Equity and Human Rights, Civic Life, IPR staff, the Portland Police Bureau, the Mayor's Office, and each Commissioner's Office. The feedback received helped build the candidate profile and informed the questions that will be asked during the interviews. The resulting candidate profile highlighted, in addition to the typical minimum qualifications, qualities including leadership; oversight and accountability; community engagement; and a focus on diversity, equity and inclusion.

The recruitment process will include two rounds of interviews. The second round of interviews will include three different panels plus one-on-one interviews with the City Auditor. The first panel will be



comprised of IPR staff and the second will include representatives from the Police Bureau and Police Commissioner's Office. The third panel will be comprised of community members, which will, depending on availability, include representatives from the Citizen Review Committee, the Portland Committee on Community-Engaged Policing, the Oregon Center for Public Policy, and a past IPR complainant. Those interviews are currently being scheduled and the panel members finalized.

#### **Community Outreach**

IPR Senior Outreach Coordinator Irene Konev made a presentation on the IPR commendation and complaint process at South East Public Safety Committee and at the Muslim Advisory Council meeting. She attended REACH Luncheon, Oregon Association of Minority Entrepreneurs Trade Fair and Navigating Networking Event at Portland Community College.

To promote the IPR director recruitment Konev connected by phone, in person and by email with Friends of Children, Slavic Advisory Council, Muslim Advisory Council, Urban League, Asian Pacific American Network of Oregon, Immigrant & Refugee Community Organization, Oregon Humanities, Oregon Assembly For Black Affairs, Latino Network, Diversity in the Workplace, Coalition of Communities of Color, Oregon Association of Minority Entrepreneurs, OHSU Equity and Diversity Office, Clackamas County Equity Diversity and Inclusion, as well as local colleges, businesses, churches and with leaders of many other local organizations.

IPR Investigators Vince Elmore and Eric Berry attended and recruited at the Inter-faith Peace and Action Collaborative meeting.

### **CRC Community Dialogue**

In collaboration with the Portland State University Law Enforcement Contacts Police and Data Committee the CRC held a Community Dialogue on Police Crowd Control Practices at Portland State University on April 10<sup>th</sup>. IPR staff attended and supported the dialogue.
