### 1. Independent Police Review (IPR) Work Plan / Accomplishments

## **Department of Justice Status Hearing**

During the Settlement Agreement status hearing on February 25, Judge Simon asked the City to revisit the the community engagement portion of the agreement and set a status hearing date for next year. The Department of Justice has found the City in substantial compliance with the terms of the Settlement Agreement.

## IPR Staff Attends Trauma Informed Training

IPR staff and Internal Affairs staff attended a two-hour training on the impact of trauma in the daily work of police oversight. Staff learned to recognize trauma and find supportive responses to the impact of trauma.

## New CRC Member On-Boarding Underway

Potential new members for the CRC have been selected and are in orientation with a target completion date around mid-March.

### International Delegates from Ukraine

IPR Director Ross Caldwell, Deputy Director Dana Macaulay and CRC member Vadim Mozyrsky presented the IPR commendation/complaint process to delegates from Ukraine. It was a dialogue about law enforcement oversight, where best practices were shared.

### **PPA Contract**

The City is currently negotiating the new PPA contract. Initial meetings have reportedly been focused on setting the ground rules for further negotiations.

IPR Senior Community Outreach Coordinator Irene Konev attended and networked at Oregon Association of Minority Entrepreneurs, Oregon Native American Chamber networking event, Black History Month Lunch and Learn, PDX Women in IT networking event, Hispanic Metropolitan Chamber of Commerce networking event, Say Hey, and Slavic Festivity at Immigrant and Refugee Community Organization. Konev coordinated and led three meetings between the leaders of African Youth and Community Organization and IPR leadership. Konev had one meeting with staff of Latino Network
