#### **OPENING AND INTRODUCTIONS: SAM BARASO, PCEF**

- The meeting was called to order at 6:02 PM.
- The quorum was met.
- Mayor Ted Wheeler joined the meeting at 6:02 PM. He acknowledged the committee's hard work
  and that the city could not have balanced its budget without the committee. He stated it was a winwin.
- Ranfis Giannettino Villatoro is glad a middle ground was found. He asked that PCEF not be referred
  to the ballot and for the committee to be consulted in the future, as partnering and collaboration
  have been challenging at times.
- Robin Wang joined the meeting at 6:05 PM.
- Faith Graham joined the meeting at 6:07 PM.
- Megan Horst emphasized that PCEF rose to the occasion and faced a lot of pushback. It is not PCEF's
  mission to solve the city budget challenges.
- Mayor Ted Wheeler recognized that the committee was put in a difficult position, but a middle
  ground was found. It would be a tragedy for PCEF to return to the ballot. He pledges that he and
  Bobby Lee are available to the committee at any time, and the committee will be included in the
  budget evaluation process.
- Committee members and staff introduced themselves.

#### **PUBLIC COMMENTS: SAM BARASO, PCEF**

• Babs is relieved to hear the Mayor say that he wants to avoid PCEF being referred to the ballot. Babs will continue to support the committee and is inspired by them.

#### APPROVAL OF MEETING MINUTES: SAM BARASO, PCEF

- Megan Horst motioned to approve the November 16, 2023, January 25, 2024, January 31, 2024, and February 2, 2024, Meeting Summaries. Robin Wang seconded it.
  - Approved: November 16, 2023, January 25, 2024, January 31, 2024, and February 2, 2024, Meeting Summaries were approved. Paul Lumley stood aside.

#### **GENERAL PROGRAM UPDATES:** SAM BARASO, PCEF

- Sam Baraso provided an update on RFP #3. The recommendation will be taken to the city council in July or August 2024.
- Sam Baraso reported that 12 additional staff members will join the team. Cady Lister is transitioning out of her role.
- Sam Baraso reported that the City Climate Projects 2024 rollout is slower than anticipated.

#### **REVIEW PROCESS FOR COLLABORATING FOR CLIMATE ACTION: SAM BARASO, PCEF**

- PCEF is anticipating a large volume of submissions, and the process will be very competitive. The
  scoring panel will recommend six to eight applicants to submit full proposals to the committee. The
  committee will recommend a package of full proposals to the city council.
- Faith Graham volunteered to join the scoring panel.

### **DISCUSSION OF PROPOSED CODE AMENDMENTS:** MEGAN HORST AND RANFIS GIANNETTINO VILLATORO, CO-CHAIRS

- A code amendment is required for PCEF interest to be allocated for fiscal year 2024-2025
  expenditures using a one-time use of actual interest earned on the Clean Energy Fund in the fiscal
  year 2022-23. The amount in question is \$7.6 million, which is required for the City Council to pass
  the city budget in June 2024 and will go into the city's general fund.
- Ranfis Giannettino Villatoro emphasized that the committee must be consulted before any code
  changes. He introduced language requesting that the City Council consult with the committee for
  any code changes. The intent of the language is for the committee to learn about the proposal, hear
  from the community, and allow the committee to deliberate.
- Committee members are frustrated that the funds will not be used as originally intended. One
  member asked for measures to protect against future code changes incompatible with PCEF's intent.
- The committee members' temperature checks ranged from feeling okay to wariness and concern that the committee is complicit and that language will not fix the power issues.
- **Action Item**: Sam Baraso will schedule a lunchtime meeting for the committee to vote on the language.
- The committee asks that community groups submit letters.

#### PREVIEW OF PCEF DASHBOARD: SAM BARASO AND VANIA FONG, PCEF

- Sam Baraso presented the dashboard development phases. Currently, PCEF is in phase one.
- Vania Fong and Sam Baraso demonstrated the dashboard. Capturing direct beneficiaries will be developed later down the road.
- The dashboard beta version will go live in July 2024.
- A committee member suggested adding stories demonstrating co-benefits and climate impact per dollar and project, climate resilience, priority populations, and programs broken down by topics.
- Two committee members would like more stories incorporated.
- PCEF communications staff is working to gather stories from grantees and working with the data analysts to share stories.
- A committee member would like to schedule a summer field trip with elected officials, committee
  members, staff, and the media to showcase PCEF projects. The staff is considering the best way to
  go about this.
