Planning and Sustainability Commission Hearing on: The Better Housing by Design Project

Why am I receiving this notice?

You are receiving this notice because you have expressed interest in being notified of certain Bureau of Planning and Sustainability projects, you are on one of our advisory groups, or you are a member of a neighborhood or business association.

What is this project about?

The goal of the Better Housing by Design project is to update Portland's multi-dwelling zoning rules to better meet the housing needs of current and future residents. The project is proposing amendments to the Zoning Code, Zoning Map, and Comprehensive Plan and Map. The proposed changes include amendments to allowed development intensities to expand the range of housing options in the multi-dwelling zones. Other amendments allow for limited amounts of commercial uses along major corridors, provide new development bonuses for projects with affordable housing, and update regulations related to building design, outdoor spaces, parking, setbacks and other development standards.

How can I review this proposal?

The Better Housing by Design Proposed Draft includes the following:

- **Proposed Draft Summary** - Short summary of the Proposed Draft's major proposals
- **Volume 1: Staff Report** - Summary and analysis of draft Multi-Dwelling Zoning Code and Map amendments
- **Volume 2: Zoning Code Amendments** - Draft Zoning Code and Comprehensive Plan text and commentary
- **Volume 3: Additional Zoning Amendments** - Additional code amendments updating other regulations for consistency
- **Appendices**
