Emergency Ordinance

*Authorize contract with the lowest responsible bidder for the NW Thurman St Bridge Painting Over Macleay Park Project

Passed

The City of Portland ordains.

Section 1. The Council finds:

1. On July 22, 2020, by Ordinance No. 189562, City Council authorized execution of an Intergovernmental Agreement (IGA) for design and construction management services for the NW Thurman St. Bridge Painting Over Macleay Park Project.
2. The project consists of designing shelf-ready plans to paint and repair the trusses and bents on the NW Thurman Street Bridge No. 25B15 over Macleay Park in the City of Portland.
3. Full funding of this project is allocated from the Statewide Transportation Improvement Program (STIP). The Grant No. associated with this Project is TR000309.
4. The total Project cost is estimated at \$4,885,290.
5. The Project received NTP on September 10, 2024 from ODOT and PBOT is requesting permission to move forward with bidding the project for construction.
6. PBOT has allocated funds for FY 2024-25, and proposes construction, inspection, and management of the project in FY 2025-26.
7. The Bureau's level of confidence in the cost estimate for this Project is high, the Project scope is defined, and plans and specifications are final.

NOW, THEREFORE, the Council directs:

- A. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to negotiate and execute a contract,

- Authorize Bidding for the federally funded NW Thurman St. Bridge Painting Over MaCLeay Park (Portland)

- The total cost for design and construction of this project is \$3,434,545 funded with federal funds, and GTR funds associated with Grant number TR000309.
- The project is budgeted under T00722.C42.
- This ordinance is to authorize bidding of the construction contract.
- This project is currently budgeted for Construction and formally requests authorization from Council to bid this project.

- This project will benefit the community by providing Structural Upgrades to the NW Thurman St. Bridge including an upgraded coating of paint.
