PROPERTY DESCRIPTION:

Subject is a corner lot above the street grade approx. 2 feet, fronting on N. Gantenbein 45' and a depth along N. Knott Street of 54'.

Improvements consist of a frame 2-story up and down duplex, with an attached garage in very deteriorated condition. The exterior of the dwelling is of shingle and cedar siding in poor condition; composition roof is good with good gutters and downspouts on the main dwelling with very poor gutters on the porch area. There is approx. 1,058 sq.ft. of living area on each floor. Main floor has an entry hall; a front room; dining room; two bedrooms; bath with 3 white fixtures; kitchen with fir cabinets, poor vinyl floor, pantry sink and wired for range.

Second floor apartment has a front access stairway, walls of which are in very poor condition. It has basically same floor plan as first floor heated however by a circulator gas heater. Condition of second floor is much poorer than first floor. There are 2 accessways to basement to provide entrance from each apartment. Basement has concrete floors, 2 laundry trays, modern forced air oil fired furnace piped to lower floor only, one automatic electric hot water heater and one gas hot water heater, storage room for tenants. Built in 1907.

Zoning: A 2.5 \$ Multi-family residential zone, requiring 2,500 sq.ft. of area for each living unit with limited sign-board control.
