PROPERTY DESCRIPTION:

Subject property has 90' of frontage on N. Williams Avenue and 65.5' frontage on N. Stanton Street, being a corner lot and located on the left hand side of a one-way street.

Property is improved with a one-story combination service station and garage, containing 4,320 sq. ft.
