Site is a large, level, corner, partially landscaped 80'x108' lot less approximately 300 sq.ft. off of the northwest corner of the property. The property is approximately 4 feet above street grade. All public utilities

are connected.

Improvements consist of a large "L" shaped concrete block Church building with 3780 sq.ft. of area built in 1955 with the North portion of the building having been built in 1965. Main Church area is heated with an FHA piped oil furnace located in a furnace room. Northerly portion is plumbed for two 1/3 bath units. Small kitchen area with gas water heater and gas range, 9 ft counter unit and small storage area. Exterior is of concrete block, composition roof and GI gutters. Construction is of fair average quality. Maintenance is average.
