PROPERTY DESCRIPTION:

The site is a 40'x108' lot, 4 feet above the street grade with all public utilities connected. Onsite improvements include front lawn, front concrete steps, concrete sidewalks at the side, shrubs, trees and some fencing.

Improvements consist of a 1-story and attic frame bungalow dwelling built during 1930 with 1144 sq.ft. of living area on the main floor. It is presently used as a duplex.

Main floor is rented and has fir floors, lath and plaster, average fir builtins, electric baseboard and wall panel heat; 2 bedrooms and I modern bath; living
room; dining room; kitchen with good vinyl floors, good cabinets, good plumbing
and wired for range and refrigerator. There is access to a full basement which
has concrete floors, concrete walls. There is a freezer in this area which in
order to remove some stairway renovation would be required. There is wall-towall carpeting in the living room.

Second floor has access from the front porch, fir treads, lath and plaster walls. There is an open combination living kitchen area, modern mahogany walls, modern sink, formica cabinets, good vinyl floors and a large storage area. There is a hall bath with 3 modern fixtures, colored, good floors, good wall finish. There are 2 bedrooms, I with mahogany paneled walls, fir floors; second is larger and has good lath and plaster walls and a good closet. There is an air conditioning unit in the wall of the kitchen area.

Exterior has recently been covered with aluminum siding. There is a lifetime slate covered roof in very good condition. The porch is made of concrete and has some brick trim.

There is a 9'x12' garden shed which has some bunk beds, portable electric heat, electric lights, inside finish of fir and fir floors. This is probably one of the most modern and newest homes in the Emanuel community.
