MEMORANDUM

TO: Members of the Citizens Planning Board

FROM: David H. Weed, Chairman

The following items need attention before our next meeting. Please read them carefully and give me any response you have.

I. Working Committees: The Executive Committee proposes that the Working Committees be re-established at once in the following manner:

1. Voting members of each Working Committee shall be one representative from each recognized neighborhood organization plus two members of the Citizens Planning Board.
2. Each Working Committee shall elect its own chairman.
3. All Working Committee meetings shall be open to all interested persons for purposes of input and discussion.
4. Staff persons assigned to each project area will work with the Working Committees as implementation of each program is developed.
5. Recommendation for contract approval or program changes will come to the Citizens Planning Board through the Working Committees.

NOTICE - While this cannot become official until adopted by the Board, it is my intention to begin the convening of Working Committees under this procedure whenever there is work for them to do so that staff and Board cooperation can go forward as fast as possible. If you have serious objections to this proposal let me know at once.

II. Child Care Proposal: The two members of the Citizens Planning Board appointed to work on the Child Care Proposal are Mrs. Strong and Mrs. Barker.

III. Dinner Meeting: In order that we can meet new Board members, exchange informational material, and shorten the length of the Board meeting, the Executive Committee proposes that we meet for dinner at Eve's at 5:45 p. m. on October 7. We will transact no business at dinner, and will leave the Restaurant to assemble for the regular meeting at 7:30 p. m. Each Board member will be responsible for the cost of his own meal.

MEMORANDUM

TO: Members of the Citizens Planning Board

- IV. Multi-Service Center: The Advisory Board of the State Multi-Service Center has complained that a member of the Citizens Planning Board stated on television that Model Cities was cut out of the operation of the Multi-Service Center because we had no representation on the Center Advisory Board. The implication was given that the Multi-Service Center or its Advisory Board was to blame for this.

The fact of the matter is that we were without representation there because of 1) the delay between the time Mrs. Yee ceased to function as a Board member and the time she submitted her resignation and 2) an additional delay when I did not realize that Mrs. Yee had been our representative on the Advisory Board and, therefore, did not appoint a replacement. This situation was corrected with the appointment of Mrs. Cogan - announced to the Board about six weeks ago.

The point of this is -

1. Lack of continuous representation has been the fault of Model Cities action or inaction (mine included) and not the fault of the Multi-Service Center people, and
2. Board members need to be very careful to be accurate in any public statements, and to avoid unnecessary criticisms of other agencies.

V. Committee Reports:

1. Chairman are hereby requested to submit at least summary reports in writing.
2. Under usual conditions, all recommendations to be acted on by the Board should be submitted in writing.
3. Whenever possible these shall be delivered to the office by the Thursday prior to each regular meeting for mailing to Board members.
4. Materials not mailed shall be delivered to the office the day prior to the meeting for mimeographing so that distribution can be made at the meeting.

Citizens Planning Board and Executive Committee - Background

The following information is presented with the thought that it might be useful for your meeting at 4:00 pm today with the CPB Executive Committee. If you feel it would be appropriate for me to attend that meeting, please let me know.

CPB Structure

The existing structure was developed jointly by local citizens and officials to meet the HUD requirement for "the constructive involvement of citizens in the Model Neighborhood area and the city as a whole in planning and carrying out the program".

The Board has sixteen elected members, elected two each from eight sub-neighborhoods (basically school attendance areas). In addition, there are eleven members appointed by the Mayor. (They may be from inside or outside of the MC area). All Board positions are for a two year term, with one-half expiring each September. The Board annually elects a chairman and other officers.

CPB Executive Committee

This committee meets between CPB regular meetings and it has been used effectively by Jordan as a sounding-board and prime-supporter to prepare for business coming to the full CPB.

The nine members of the Executive Committee are as follows (a and e show appointed or elected capacity); Fred Flowers (a), Leroy Patton (e), Marian Scott (e), Clara Peoples (e), Opal Strong (e), James Loving (e), Bob Rogers (a), Ben Bernhard (a), and Josiah Nunn (a, past chairman).

Future Possibilities

The CPB itself has recently appointed a Task Force to review Citizens Participation structure. While the main emphasis will likely be on involvement of citizens in working committees and a general better response,

the study could include recommendations about the basic structure itself. Where the eight sub-neighborhoods have been grouped into five planning areas, suggestions have been made to have elected board members from five rather than eight geographic units. That would mean complications in the King-Vernon-Sabin and Boise-Humboldt areas which now have several representatives.

Another approach would be to phase out the appointed board members and move toward a reduced size of all elected members. This approach would look more like a district planning organization which would very well be duplicated in other geographic sections throughout the city. The allocation of extra resources could be continued with this board.

The five top candidates will be interviewed at a special executive session of the Board on Monday, May 18, at 7:00 p.m.

Rules for the meeting and score sheets will be provided by the Committee to members of the Board. The score sheets will be tallied by the Committee and the top three candidates will be submitted to the Mayor for him to make the appointment of a Director.

Mrs. Norman moved to amend the main motion to remove monies from the evaluation budget to Consumer Protection proposal as accepted. It was seconded, and the motion carried.

Mrs. Hays moved that the entire staff be hired on a twelve-month basis the same as the Director. Seconded; motion carried.

Mrs. Nunn moved that Mr. Loving's proposal be on the next agenda. It was seconded and passed.


