

RE: Fremont Bridge Relocation Obligation

Under HUD regulations, activities which require ralocation benefits, but for which no relocation funds are available, must be covered by Hodel Cities relocation resources if the activity is within the Hodel Meighborhood and conforms to the objectives of the Comprehensive City Demonstration Plan. Displacement caused by an "interim opening" of the Fremont Bridge Ramps would, therefore, require Hodel Cities coverage if no other resources are available.

It is my understanding that there has been discussion regarding city payment of relocation benefits to be reinbursed by the state when the long range plans are implemented on Fremont Street. If such an arrangement can be agreed to, it is important that Nodel Cities be so informed. The Citizen's Planning Board has instructed the staff to identify surplus funds. In order to accurately ferecast future encumbrances on relocation funds, we must know as soon as possible whether the city will seek coverage of relocation expanses by Nodel Cities. I would, therefore, request that Dennis Milde be responsible for this determination at the earliest possible date.

Please let me know if there are further questions which I could elaborate upon.

Re: Planning Bureau In-Kind Contribution to the Union Avenue Redevelopment Program

As you are aware, a commitment was made on behalf of the Planning Bureau to provide approximately \$8,000 in contributed services towards the first phase of the Union Avenue Redevelopment Program. I would like to make a specific recommendation as to how the Planning Bureau might fulfill that commitment, and at the same time provide continued employment of Model Cities' employees. At present, Model Cities has a physical planning staff of four individuals: Planning Program Coordinator, Mike Henniger; two City Planners, Mike Lyons and Tim Nolan; and an Assistant Planner or Planning Aid, John Neal.

My recommendation would involve Mike Lyons and Tim Nolan, both of whom have received a civil service rating of City Planner. The recommendation is as follows:

Between now and the end of the fiscal year, the Planning Bureau would assume half the salary load for both Mike Lyons and Tim Nolan. The other 50% of their salary would be carried by Model Cities. Mike and Tim would be assigned to the Union Avenue Redevelopment Program for 50-75% of their time. This shared salary arrangement would continue through June, 1974. This would serve as a probationary period for both. In June, based on an evaluation of their performance, they would be assigned to the Planning Bureau as full-time staff provided City Planner positions are available. If in June no City Planner positions are available, two options could then be pursued.

1. Continue both Mike Lyons and Tim Nolan on temporary status using 701 Funds for the 1974-75 fiscal year. During that year, allow them the opportunity to transfer into permanent positions if they become available.

2. If no positions are available and there is no opportunity to use 701 Funds, provide them full-time assistance in finding employment and continue them on a temporary basis until they are able to secure new employment.

Re: Establishing two temporary positions in the Office of Planning and Development to carry out a Redevelopment Program for Union Avenue.

On October 4, 1973, the Model Cities Citizens' Planning Board approved the allocation of \$50,000 to initiate a redevelopment program for Union Avenue. The approval calls for the establishment of a project planning team to be administered through the Office of Planning and Development.

Job descriptions for two positions are attached. The positions are temporary with a duration through the end of the current fiscal year. The job classification "Project Planning Coordinator" is an existing classification in the City. It has a flat rate salary of \$9.62/hr. (See Ord. #137189, attached) This position would be underfilled, paying a rate of \$9.04/hr.

The job classification "Community Organizer" is one not currently listed by the City. The attached job description defines the responsibilities and qualifications. The job will have a flat rate salary of \$7.22/hr.

It is important that this matter be acted on as quickly as possible since an ordinance has to be prepared for submission to City Council by Friday, November 2, 1973.

ORDINANCE No.

An Ordinance extending the temporary position of Project Planning Coordinator in the Office of Planning and Development to September 15, 1974, changing the rate of pay for this class, transferring \$6,966 from General Operating Contingencies, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 136391 adopted by the Council on April 25, 1973 created a 'temporary position of Project Planning Coordinator in the Office of Planning and Development to December 31, 1973; that this position was established to coordinate the implementation of planning for the downtown riverfront area; that the initiation of this project and the hiring of the coordinator have been delayed; that the duration of this project was under-estimated; that it is now necessary to extend the project and the position of Project Planning Coordinator to September 15, 1974 and to provide funding in the 1973-74 budget beyond December 30, 1973 to June 30, 1974; that the salary range for this classification is \$7.58 to \$9.04 an hour; that the Mayor as Commissioner in charge has recommended changing the salary for this classification to the flat rate of \$9.62 an hour to be commensurate with the skills and experience required; and that the position authority should be changed accordingly; now, therefore, the temporary position of Project Planning Coordinator in the Office of Planning and Development is hereby extended to September 15, 1974, and the salary for this class is hereby changed to the flat rate of \$9.62 an hour.

Section 2. In order to provide appropriation for the increased expenditures for the Project Planning Coordintor to the end of the current fiscal year, appropriations are hereby transferred within the General Fund as follows:

Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that planning for the expanded downtown riverfront area may be implemented without undue delay; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.



Background - Union Avenue Redevelopment

Over the last year, considerable attention has been focused on Union Avenue. Three independent studies, one on transporation, one on traffic circulation, and one on economic development, have all identified Union Avenue as a central factor in the solution of a whole series of physical, economic and social problems. Neighborhood Plans and the Comprehensive Plan Study for Model Cities have also recognized the importance of Union Avenue and its impact on surrounding Neighborhoods. In August of last year, each Neighborhood Association and the Citizens Planning Board adopted 11 transporation policies which included Union Avenue as the highest priority project for transportation policies which included Union Avenue as the highest priority project for transportation improvements.

After the Citizens Planning Board had adopted the 11 policies on transporation, Jessie Hudson, Chairman of the Economic Development and Transporation Working Committee, met with Mayor Neil Goldschmidt to discuss City action on the policies adopted by the Citizens Planning Board. At that meeting the Mayor indicated his <u>strong</u> support and interest in a redevelopment program for Union which would go beyond simple street improvements. The Mayor challenged Model Cities to propose a broad, comprehensive program of physical, social and economic projects and indicated that he would personally give such a program the full weight and prestige of his office to insure things would happen.

Existing conditions on Union Avenue can be separated into three major and significant aspects.

- 1. <u>Physical</u> Union Avenue is a poor traffic arterial with traffic jams during rush hours, frequent traffic accidents, and poor pedestrian crossing. When the Fremont Bridge opens, these conditions will worsen. Because Union is crowded, many cars use residential streets causing Neighborhoods to become concerned for the safety of their neighborhood streets. While Union Avenue was once a successful business area, the decline in business activity has resulted in vacant store fronts, deteriorated buildings and vacant used car lots.
- 2. Social As the major focal point of Model Cities, Union Avenue continues to be a psychological depressant on the efforts of Model Cities residents to improve their environment. Its empty buildings and unused parking lots are an attractive nuisance for many of the youth of Model Cities. Many of the social action agencies and programs that serve the Model Cities area are located along Union Avenue, often in old store fronts or remodeled facilities that seem to be second-hand or make-shift efforts. There is little to evidence of a solid or long-range commitment of these agencies to serve the needs of Model Cities residents.
- 3. <u>Economic</u> Little rejuvenation has occurred recently because many businessmen cannot afford, or are unwilling to make financial investment along Union Avenue. Bringing about the economic revitalization of Union Avenue will require substantial resources both from the public and private sector. Employment training and placement programs need a neighborhood focus and a demonstration that jobs are available.

Proposal

In order to fulfill the need to integrate social, physical, highway and transit improvements many varied and independent agencies must be deeply involved. Many specific projects included under the umbrella of the Union Avenue Project would be developed by staffs of several different agencies. This interdisciplinary approach will require a strong central project control and coordination.

The motives of Model Cities in initiating the Union Avenue Project follow clearly from the original definition of Model Cities as a demonstration project with finite life-span. The program was established to show what is possible when a variety of resources were brought together to focus on a single area. Union Avenue, as a project commitment from the City, will carry beyond the life-span of Model Cities and will involve the people of the community in a substantial ongoing process of neighborhood involvement and neighborhood improvement.

In order to assure that these goals and objectives for Union Avenue are met, as well as, to assure the commitment of the City, the State and private agencies to be intimately involved in the Union Avenue Project. It is important that Model Cities begin now to establish a specific project description for the planning phase of Union Avenue. Additionally, it is necessary for Model Cities to propose the structure, coordination and involvement of such agencies as the Portland Development Commission, the State Highway Department, Portland Economic Development Corporation, Bureau of Labor, Department of Transporation, Tri-Met, and other similar agencies.

During the first one to two years, the cost of the Development Plan preparation and project implementation and administration will have to be borne by the sponsoring agencies. Although final details have not been worked out at this time, the level of project planning and administrative costs are estimated as follows:

Based on the above estimates, the Citizens Planning Board was requested to allocate \$50,000 for Union Avenue Redevelopment and to authorize staff and members of the Board to meet with other agencies of the City and State to insure their commitment and financial contributions to the inital phase of the project. It is understood that no funds will be authorized from this allocation until the Working Committee and Citizens Planning Board have approved a project description for use of these funds. Page 3

Model Cities can expect several things from initiating such a project. These are:

- 1. This is not just another planning program this is the initiation of a specific improvements program for Union Avenue.
- 2. By providing a significant part of the front-end money Model Cities can enlist the contributions from several other sources, specifically the Portland Development Commission.
- 3. Through the initial funding Model Cities can exercise control of the planning and execution of the project.
- 4. The control can insure that Model Cities residents and businessmen participate in the economic benefits of new construction, new jobs, and new business.

The specific request is the Model Cities Citizens Planning Board approve the allocation of \$50,000 to initiate the Union Avenue Redevelopment Program. This allocation will authorize the C.D.A. staff, working in conjunction with board members, to draw up a specific project description. In addition, members of the board with staff will meet with the Mayor and other City and State agencies to insure their commitment and contributions to the project.

Enclosed is a chronological package of what has transpired to date on the Union Avenue Redevelopment Proposal. Two meetings have occured of which you should be appraised. On 13 November 1972, a meeting was held in the office of Portland Economic Development Committee, 417 S.W. Washington. In attendance were Warren Nunn, Frank Cox, Mike Wright, and Curt Madder all of PEDCO; Phil McLaurin, Comm. Goldschmidt's office; Mike Henniger and Dennis Wilde, Model Cities; Charles Jordan was invited but could not make it. The crux of the meeting was that PEDCO is very interested and would like to participate. They have manpower and resources that can be matched with Model Cities money on 75-25% participation basis. They would be willing to provide staff assistance to do the Economic Feasibility and Market Analysis work necessary in the front end of the project as well as specific involvement in any commercial/industrial development that might be generated.

On 22 November 1972, a meeting was held in Commissioner Goldschmidt's office. Those present were Neil Goldschmidt, Phil McLaurin, John Kenward, Chuck Olson, and Dennis Wilde. The Development Commission staff was fully supportive of the proposal and liked the idea of a multi-agency effort tied together under the control of the Mayor's Office. Kenward offered to tie the Eliot planning effort closely with the Union Avenue effort. He suggested the possibility of a joint site office somewhere on Union Avenue in the Eliot neighborhood. He also suggested direct contacts with Washington, D.C., both H.U.D. and D.O.T., to gain support for such an ambitious project.

After this meeting a meeting was held in Charles Jordan's office with Charles Jordan, Mike Henniger, Phil McLaurin, and Dennis Wilde. Charles

Re: Establishing two temporary positions in the Office of Planning and Development to carry out a Redevelopment Program for Union Avenue.

On October 4, 1973, the Model Cities Citizens' Planning Board approved the allocation of \$50,000 to initiate a redevelopment program for Union Avenue. The approval calls for the establishment of a project planning team to be administered through the Office of Planning and Development.

Job descriptions for two positions are attached. The positions are temporary with a duration through the end of the current fiscal year. The job classification "Project Planning Coordinator" is an existing classification in the City. It has a flat rate salary of \$9.62/hr. (See Ord. #137189, attached) This position would be underfilled, paying a rate of \$9.04/hr.

The job classification "Community Organizer" is one not currently listed by the City. The attached job description defines the responsibilities and qualifications. The job will have a flat rate salary of \$7.22/hr.

It is important that this matter be acted on as quickly as possible since an ordinance has to be prepared for submission to City Council by Friday, November 2, 1973.

PROJECT PLANNING COORDINATOR

I. RESPONSIBILITIES

Overall coordinator of the project planning team who reports directly to the Mayor and Administrator of the Office of Planning and Development. Responsible for both the project planning and implementation phases of the redevelopment program. Responsible for coordination of governmental units, agencies, and interest groups. Responsible for liaison between the overall redevelopment program and projects carried out by involved agencies and groups.

II. EXAMPLES OF DUTIES

Coordinates the planning and implementation of all work tasks in the redevelopment plan Workscope. Develops and maintains effective working relationship between project planning team and the Steering Committee and various technical subcommittees. Coordinates all activities of contracted services and in-kind contributions for the project with the various functions and activities of the workscope.

III. QUALIFICATIONS

Ability to organize and direct a technical staff in the development of the planning and implementation phases of the project. Ability to communicate with technical staff, representatives of local government, involved agencies, and interest groups.

IV. TRAINING AND EXPERIENCE

Master's degree in Urban Design or City Planning or a related field. Eight years' experience in program planning, administration, and evaluation.

COMMUNITY ORGANIZER

I. RESPONSIBILITIES

Under the direction of the Project Planning Coordinator, responsible for establishing and maintaining a structure of citizen participation and community involvement in the redevelopment plan. Responsible for providing an effective and meaningful program of public information for residents of Model Cities and the general public.

II. EXAMPLES OF DUTIES

Develop a structure for citizen participation according to the process-output model. Define roles and responsibilities of the Steering Committee and the various technical subcommittees. Together with the Steering Committee, assists in the development of citizen monitoring and evaluation techniques of the various functions of the project. Maintains liaison with community organizations, business and professional groups who have an interest in the redevelopment project. Conducts all surveys and public opinion polls connected with the project.

III. QUALIFICATIONS

ORDINANCE No.

An Ordinance extending the temporary position of Project Planning Coordinator in the Office of Planning and Development to September 15, 1974, changing the rate of pay for this class, transferring \$6,966 from General Operating Contingencies, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 136391 adopted by the Council on April 25, 1973 created a 'temporary position of Project Planning Coordinator in the Office of Planning and Development to December 31, 1973; that this position was established to coordinate the implementation of planning for the downtown riverfront area; that the initiation of this project and the hiring of the coordinator have been delayed; that the duration of this project was under-estimated; that it is now necessary to extend the project and the position of Project Planning Coordinator to September 15, 1974 and to provide funding in the 1973-74 budget beyond December 30, 1973 to June 30, 1974; that the salary range for this classification is \$7.58 to \$9.04 an hour; that the Mayor as Commissioner in charge has recommended changing the salary for this classification to the flat rate of \$9.62 an hour to be commensurate with the skills and experience required; and that the position authority should be changed accordingly; now, therefore, the temporary position of Project Planning Coordinator in the Office of Planning and Development is hereby extended to September 15, 1974, and the salary for this class is hereby changed to the flat rate of \$9.62 an hour.

Section 2. In order to provide appropriation for the increased expenditures for the Project Planning Coordintor to the end of the current fiscal year, appropriations are hereby transferred within the General Fund as follows:

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that planning for the expanded downtown riverfront area may be implemented without undue delay; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.

WHEREAS, present agreements between the City and the State Highway Division provide that the Ivy Street ramps of the Fremont Bridge be opened to traffic when the bridge is opened approximately November 15, 1973, and

- WHEREAS, Emanuel Hospital intends to continue and expand its facility at 2801 N. Gantenbein Avenue as a regional medical care center and the Council wishes to encourage such continuance and expansion; and
- WHEREAS, Emanuel Hospital has represented to the Council that direct access from the west end of the Fremont Bridge is essential to its above intention; and
- WHEREAS, residents of the Model Cities area, as represented by the Model Cities Citizens Planning Board, have expressed concern that traffic from the ramps will have a severe negative impact on the livability of the surrounding area and have recommended that no ramps be opened until a long-range solution is designed and implemented; and
- WHEREAS, the City has applied for Federal Aid for Urban Arterials funds to design a long range solution to the problem;
- NOW, THEREFORE, BE IT RESOLVED
 - That the Mayor is authorized to reach an appropriate agreement with the Oregon State Highway Division postponing the immediate opening of the Fremont Bridge Ramps.
 - 2. That the Oregon State Highway Division is requested to undertake, with the City, the necessary steps to design and implement a permanent solution no later than November 1, 1978.
 - 3. That the Office of Planning and Development, with the assistance of the City Traffic Engineer, is instructed to work with representatives of the Eliot, Boise, Irvington and Sabin neighborhoods, Emanuel Hospital and the State Highway Division to present an interim solution to Council no later than December 15, 1973, providing for access to Emanuel Hospital from the Fremont Bridge within a reasonable period with appropriate pre-

cautions for protecting the livability of the neighborhoods. At least the following should be considered:

- a. retaining parking along Fremont Street east to Union Avenue.
- b. a traffic diverter at the intersection of Williams and Beech, and converting Williams and Vancouver into two-way streets.
- c. signing from the bridge which refers only to Emanuel Hospital and local access.
- d. signalization and directional signing which discourages traffic moving north into the Boise neighborhood.
- e. reconstructing the present ramps to minimize the flow of traffic.
 - f. acquiring residences along Ivy Street between the ramps and Williams Avenue that may be adversely affected by such interim solution.
- 4. That the Oregon State Highway Division be requested to undertake, with the City, the measures necessary to implement the agreed upon interim solution and that the bridge ramps be opened immediately thereafter, to occur not later than June 1, 1974.
- 5. That the Council intends to provide for the ramps to be closed if, during the period preceding implementation of a permanent solution,
 - a. traffic counts on streets in the area exceed estimates of the City Traffic Engineer included in the interim plan,
 - b. air and noise pollution levels exceed standards to be designated in the interim plan, or
 - c. traffic accidents in the area are found by the Council to be excessive as a result of the ramps being open.
