Dear Mrs. Flowers:

Here are some ideas for the Citizens Participation Workshop:

Proposal writing guidance so citizens who have an idea for a program may get it funded. This knowledge is important after City Demonstration Agency as an entity is gone so that we may continue to operate projects for our neighborhood.

Education Section

- 1. The Education section might include investigation of alternative educational and career educational programs now available with an eye to increasing these programs and publicizing them so that youth may know that alternatives to frustration and dropping out are available.
- 2. Consideration of encouraging a new counseling system.
- Space and building design in schools to encourage rather than discourage positive self-image and learning.
- 4. The question of how much and what sort of authority schools should demonstrate to our children.
- 5. The old question of cultural bias much improved but, do we want to push for further change and how can we effectively improve this situation?
- 6. What is really happening in the teacher assistant programs? Are we utilizing the new educational insights which this interface of professional and paraprofessional is yielding?

Physical Environment and Housing Section

- 1. The possibility of and feasibility of neighborhood control of what is built and where this includes zoning control.
- Consideration of the need to maintain all socio-economic levels in the neighborhood and how to implement this.
 - a.) Is RDP capable of including social concerns?
 - b.) Should low-income housing actually include all socio-economic levels so as to prevent social isolation and to enhance the gaining of positive attitudes and habits?

- 3. How imaginative is the land use planning which is going on in the Model Neighborhood?
- 4. Are social needs being programmed into physical planning or are we creating new concrete slums?

Enclosed is a pro forma invoice for the Model Cities Seminar of February 26, 1972, based upon our discussion of your needs.



Questions & Answers When Must I Register?

At any time, however you must be a U.S. citizen, a resident of Oregon for at least six months prior to the election and at least 18 years old by the day of the election. You must be registered at least 30 days prior to the primary and/or general election. (See important dates for voters on last page of this pamphlet.)



What if I meet the requirements a few days before the election, but after registration has closed?


Go ahead and register if you can satisfy the age and residency requirements within the 30-day period before the elections. However, you cannot register *before 60 days* or after 30 days prior to the election.



Where do I register?

It depends on what you regard as your permanent address. This question is frequently asked by college students. Your intent governs your residency. If a student intends to reside in his college community, he may register in that county. If on the other hand, he considers another community his permanent residence, he must register in that home county.

Voters may register with the county clerk at the county courthouse. In all counties, voters can also register with local community registrars often found at banks, schools, fire departments, and other locations. The registration points in your county can be obtained by calling the elections department or county clerk in
