The Health Sub-Committee in discharge of the February 19, 1974, mandate of the Citizens Planning Board has determined the following facts:

- (1) Health need priorities as determined by the Health Working Committee involves funding for the Pediatric Medical-Dental Clinic at the Multi-Service Center; and for the Albina Health Care Center.
- (2) Of these priorities, only the Albina Health Care Center has been refunded by the Citizens Planning Board.
- (3) The other two (2) priorities were assumed to have been assured of funding by Multnomah County.
- (4) Confusion concerning obligation to maintain these functions and overlapping jurisdiction between city and county have delayed final decisions regarding funding for these projects. (See attached legal opinion)

(5) Efforts of the Health Working Committee and the Community Health Planner, have resulted in some commitments on the part of the County Health Department and negotiations between the County and City Boards of Commissioners to find additional funds in order to maintain the Pediatric Clinic at the Multi-Service Center.

It is the conclusion of the Health Sub-Committee that the Citizens Planning Board take the following actions as a demonstration of its concern for the Health needs of the Model Neighborhood.

- (1) From funds available for reprogramming, allocate \$31,900 to the Pediatric Clinic at the Multi-Service Center as a challenge grant to the County to provide an adequate facility for the 1974-75 budget year.
- (2) To provide \$9,100 for maintaining the Comprehensive Health Planning Component until December 31, 1974 in order to provide coordination of Health Services and develop future funding for Health Services in this Community.
- (3) To secure a firm commitment from the city, county, and the City-County Health Commission for future operation of a neighborhood health program which will maintain a level of services adequate to the needs of our community.

Since the beginning of Model Cities, the Health Working Committee has worked for the establishment of a health program that reflects the needs and wants of our community. We have secured and maintained a community based health planner, to ensure that responsible health planning bodies and health facilities in Metropolitan Portland have the kind of input and pressure they need from our health planner to expressour views so we can ensure our voice in what is planned and implemented in our area. We are committed to the fact that we are in the best position to plan for, decide, and control what health services we have and need in order to maintain our health.

In our community, we have brought about three community clinics that provide health care and education, without charge, to persons unable to pay, and with a commitment to uphold the dignity and respect of all who come for care. We have also secured an effective, excellent pediatric, dental and community health nursing program. We have seen to it that the County brought needed mental health services into our neighborhood, and that planning and services for the many people who are classed as mentally retarded, have a community base. We have helped to maintain special medical examinations particularly important to us, for example, sickle cell anemia, hypertension, and lead poisoning.

In struggling for a period of more than four years, we have fought for and secured the beginnings of programs that are important if we are to maintain healthy bodies and minds in our community. We need to build upon, not reduce, the services we have developed.

We know that funding to maintain our health programs has to be considered serious and deserving, as the funding of other programs that we need in order to live dignified, productive lives as citizens in this community.

We, the Health Working Committee, then want to go on record as resolving that health Services and planning and coordination of these services, be supported and maintained so we can ensure the above.

Further, we the Health Working Committee resolve that there is an immediate threat to the continued existence to the Medical and Dental Clinics at the Multi Service Center and the Albina Health Care Center.

Last year alone, the Medical Clinic has served over 10,000 patients; the Dental Clinic over 6,000, primarily children.

In the month of December 1973, the Albina Health Care Center has served 435 patients of all ages.

In essence, the plight of these clinics are of DIRE concern to everyone.

We call upon the CPB to (1) join with us in securing ongoing support of the Medical and Dental Clinics from Multnomah County, and (2) securing funds that will provide for the continuation of all of our health programs from all sources of funding.


