
I beg to thank you for your letter of September 21st, regarding poles on the Thurman street bridge, showing that the railway company has asked their engineering department to submit plans.

In this connection I take the liberty of saying that this is exactly the condition that has existed since the bridge was constructed. The railway company promised to get its engineer to get up ornamental plans and there the matter ends, excepting that I trust that in this instance if the railway company does not attend to the poles within a few days the city authorities will do so.

Any one can make a pole that would hold those wires and for the railway company to suggest that they are looking for ornamental poles, after having stuck up wooden poles on the side-walk of the bridge, is note-worthy.

Following your suggestion. I beg to report to you that on .. the Thurman street bridge there are four poles, two on each side of the bridge, which are a menance to passengers on the cars.

As you know, the tracks on the Thurman street bridge run by the edge of the side-walk, and not in the center of the bridge. The poles are also on the edge of the sidewalk. There have been two accidents on this bridge, one to a conductor within the past few weeks, and one to a passenger who was saved by his unbrella from being hurt.

When the bridge was made the street-car company agreed, through Mr. Swigert, to remove these poles and substitute steel rods of an attractive design on the outside of the bridge. It was a recognized fact that it was an error to place these poles as they are. This promise was made by Mr. Swigert personally at a meeting of the residents of Willamette Heights.

In this connection, I beg further to say that the approaches to this bridge are dangerous. There should be a railing to guide passengers to the side-walk on the bridge.



Dear Sir:

I see they are still figuring on the beauty of those poles on the Thurman Street bridge and it is fair to presume that from the time involved in the study of the architecture for these new poles they will be very beautiful, and I trust you will approve of the foregoing sarcastic remark, which applies, however, only to the railroad company.

Russell & Blyth have dug a hole on Thurman on the south side where they are building their new little one story house and they drain a large amount of surface into the hole and then dump it on Thurman Street. Having cut the grass off it carries with it mud and of course this fills the street. I asked one of the men who was digging up there if he was going to clean out the gutter and he said he was not the guilty party but that the guilty party was a man named Riley. The result of this procedure is that that side of the street is under water to day because the mud has made it impossible to keep the catch basin open at the end of Rugby Street on Thurman and if it was not for the catch basin right opposite my front door the chances are the water would have washed away a good deal of our lot.

Why can't a catch basin be put in, say about in front of Col. Jordan's house or a little above? This street is on a slant, slanting from south to north and all the water that reaches the south side of the street flows across. A couple of catch basins would relieve the trouble immensely.

In addition to this that place on the Weinhard property runs down into Thurman Street and has never been attended to and if it were drained to run into the tile drain, as easily could be done, it would keep Thurman Street good and clear. If the contractors on Willamette Heights were made to be a little careful there would be no trouble at all with the water as there are plenty of drains to carry off the water, but they are rendered useless when a hard rain comes by the carelessness of individuals.

Dear Sir:

A ten-inch tile drain runs on the south side of Thurman street to carry off the surface water from the hill beyond, the surface water being conveyed to this sub-soil drain by catch-basins.

It works very well and prevents the hill from being washed out in a heavy downpour.

This tile drain takes the water from the entire hill, excepting that in a heavy rain this is impossible. At the west end of this tile drain a six-inch drain connects with it. The six-inch drain running up the hill to the land of Weinhardt, I think it is, where they have made a large fill on Aspan street. The contractors have left this fill in such condition that the mouth of the tile drain is in danger of being clogged by mud and debris, and if this happens, the waters from the little canyon will be dammed by the fill and will not be carried off. Besides, the quantities of mud that flow down under the present situation may clog up the tile drain below.

I have written to Mr. Taylor about this matter and he has been on the ground with me, but nothing has been done. The owners or the contractors should be compelled to extend the tile drain one length so that the mouth would not become clogged.

It is impossible to thinkthat this will not clog, because the catch-basins on Aspen street which are much larger than this tile drain are closed today and will have to be cleaned before the winter

rains commence, or else Aspen street will be washed into Thurman street.
