"We grieve for every person who lost their lives across our region due to the unprecedented and excessive heat. We are seeking more information from our partners at Multnomah County to learn more about how these deaths could have been prevented, so that we might prevent them in the future.

Tragically, catastrophic climate events are something we must now regularly anticipate. We are working with our bureaus to identify how we can better support Portlanders in extreme heat emergencies, just as last year's Council developed new systems for extreme smoke and quarantine, and just as we have protocols for snow and ice.

The extreme heat reminds us that climate change affects the most vulnerable most intensely: the unhoused, the elderly, those with disabilities, those with low-incomes, and communities of color, among others. We want to thank city employees who, both in their jobs and by volunteering their time, kept Portlanders safe. Thank you to everyone who volunteered at cooling centers and checked on their vulnerable neighbors. We would especially like to lift up the work done by mutual aid groups in Lents and North Portland. We face the climate crisis together, and we will work through it as a unified, compassionate community."

Dear Mayor Wheeler:

The 51st anniversary is just ahead of Nixon's invasion of Cambodia on Apr. 30, 1970, followed by the May 4 shootings of 13 Kent State University students, with 4 dead, by Ohio National Guardsmen, and then the May 11 attack by several hundred Portland Police officers on peacefully protesting Portland State University Students in the Park Blocks. A panel was convened by Portland officials to investigate the attack at PSU and it was found months later that although the police had acted improperly no action would be taken against them and thus the case was closed. There was to be a 50th anniversary gathering of the surviving PSU protest organizers and those who supported us last May 11, however covid concerns delayed it to next Oct. 27, when college classes will be back in session. Since there has never been in all the years since the violent assault on our 1st amendment right of assembly in a public place an apology by anyone in Portland city government we would like to take this opportunity to you Mayor Wheeler, to attend our "50+1 Event" this Oct. to express a measure of regret for the bloody 1970 police attack that sent dozens of PSU students to the hospital. It would be a powerful gesture of reconciliation. I've been told that "right now is not a good time politically" for you to make any gestures of justice towards the Portland protesters of the late May, 1970 but after 5 decades of official silence perhaps its high time somebody from Portland City Hall did so. This is a naive approach to control organized drug crime organizations in Portland that profit from illegal drug trade and use intimidation and drive by murders to conduct their criminal enterprises. Jim Atwood of the JA Atwood Corporation is a front organization in Old Town for his ownership of properties that are used for drug trafficking activity by Asian organized crime persons. The City Of Portland previously sued Atwood for knowingly allowing a property to be used by Asian crime to manufacture and distribute drugs, which is only the tip of the iceberg of this organized crime enterprise hiding behind a supposed real estate office that only serves Atwood's interests. - Atwood and an Asian drug crime associate attempted to defraud me out of \$1.9 million dollar bar property I owned. I listed the property for sale with John L. Scott and Atwood's business associate claimed they were going to purchase the property, but instead conned me into giving a lease while they supposedly "got their finances in order" and never went through John L. Scott to buy the property. I was given one \$10,000 rent payment in their scam, but had about \$50,000 in tools and equipment quickly stolen by Atwood's associate, while Atwood went behind my back and my real estate agent and purchased a \$500,000 note I still owed on the property. Atwood's associate then threatened to have me murdered by a drive by shooting if I did not just hand Atwood the \$1.9 million property, while the property was used for drug activity and Atwood tied me up in court with his real estate scam. Atwood used a law office to tie me up in court for months in a foreclosure scam while his associate used the property to conduct drug deals. Atwood's associate shows off a semiautomatic weapon on his Facebook page which is typical of the weapons they use to threaten or murder victims. Atwood uses his criminal associates to acquire properties for little money and then leases them out knowing they are being used for drug manufacture and trafficking, building a multi-million dollar real estate empire of business

properties used for drug trafficking. Organized crime like this is worth millions of dollars, and has more than enough money to buy the best in semiautomatic weapons and the will to intimidate or murder to expand their empire. Taking down violent drug crime enterprises should involve funding organized crime investigation and police units along with support by the FBI and ATF. Community groups are toothless agents taking down the violence of organized drug crime in Portland. They acquire millions in properties by scams, intimidations and threats of murder to manufacture and sell illegal drugs and welcome having naive persons on the city council which gut police detectives and units to investigate and take down organized crime enterprises. Atwood's business associate uses properties to warehouse stolen vehicles and property, where semiautomatic weapons are just one of their tools of their trade. A community organization has no investigation or police tactical equipment to take down organizations. I invite any interested person to Google the court case of The City Of Portland v. Atwood as one example of how organized crime operates.
