In 2005 there was a dilapitated warehouse sitting on the land, which the owner called a 'church'. The 'church' was a front for the owner's niece's prostitution and drug dealing businesses. We regularly saw these exchanges happen in broad daylight. Since the warehouse was torn down, the lot has become a nesting place for the houseless population in Portland. In the past two years an encampment has grown exponentially, along with the piles of discarded concrete random trucks have taken to dumping on a somewhat regular basis, as well as hoardes of stolen home goods that are delivered on a bike trailer a few times a day. The drug deals continue, and the drug users are now squatting on the property, stealing from local properties and taking water from outside spigots without permission. The neighborhood would be otherwise quite safe, were it not for this one lot. Despite numerous attempts to reach out to Geza Development, we've never gotten a response.
