Regarding Land Use Compatibility Statements

A Land Use Compatibility Statement is a City response to a State Agency as to whether or not a proposed activity or use is allowed outright, requires additional approval under adopted City ordinance, or is prohibited. Neither Oregon law nor Portland Code require, or provide for, a hearing or public process prior to completing a LUCS. It is unlawful for the City to apply a different procedural process for an individual applicant. The City reviews and issues LUCS based on zoning regulations and comprehensive plan that have been adopted and acknowledged.

Regarding Zenith Energy's Request for a Title V Air Permit

It is the city's understanding that DEQ determined the LUCS is insufficient because it failed to include adjacent properties that are a part of Zeniths operations. Separately, DEQ fined Zenith for its operation of the McCall dock without authorization under its air quality permit. Zenith's failure to comply with DEQ rules regarding Zenith's operations is outside the scope of the city's LUCS review. However, the city will evaluate whether Zenith failed to comply with any of the city's adopted regulations and if enforcement action is necessary.

At this time, the City has not received any request for a new or revised LUCS from Zenith. If and/or when the City receives a request, it will be processed by Portland Permitting & Development in the same manner as all other applicants.
