ORDINANCE No.

An Ordinance authorizing the Purchasing Agent to advertise and receive proposals for furnishing all materials, equipment and labor and for constructing the Emanuel Hospital Urban Renewal Storm and Sanitary Sewer System, Phase I, for the Department of Public Works, authorizing a contract therefor, authorizing the drawing and delivery of **checks** on Trustee Fund, and declaring an emergency.

The City of Portland ordains:

Section 1. The Purchasing Agent hereby is authorized and directed to advertise and receive proposals for furnishing all materials, equipment and labor and for constructing the Emanuel Hospital Urban Renewal Storm and Sanitary Sewer System, Phase I, for the Department of Public Works, in accordance with the plans and specifications therefor filed in the Bureau of Purchases June 29, 1972, and amended June 30, 1972, and as so amended, made by this reference, a part hereof as filed in the Bureau of Purchases.

Section 2. The Commissioner of Public Works and the Mayor hereby are authorized to enter into a contract with the responsible bidder submitting the most advantageous bid for the project mentioned in Section 1 hereof. The Council hereby reserves the right to reject any and/or all bids, in whole or in part, and in the event that no satisfactory bid is received, the Purchasing Agent hereby is authorized to readvertise therefor until a satisfactory bid is received, provided that there are no changes in the plans or specifications hereinabove by reference made a part of this ordinance. Checks shall be drawn against the deposit of money by the Fortland Development Commission in the Trustee Fund pursuant to the terms of the contract authorized herein, when demand is presented, approved by the proper authorities.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order that the contract authorized in Section 1 hereof may be authorized as soon as possible, therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
