



ORDINANCE No. 130302

An Ordinance authorizing an expenditure of \$302 from the Model Cities Fund to cover the cost of Mrs. Billy R. Norman and Mr. James Loving as citizen representatives to the City Demonstration Agency Directors' meeting in San Diego, January 20-22, 1970, and declaring an emergency.


The City of Portland ordains:

Section 1. The Council finds that it would be in the public interest for a citizen representation at the City Demonstration Agency Directors' meeting to be held in San Diego January 20, 21 and 22, 1970; that Mrs. Billy R. Norman of 2816 N.E. 11th Avenue, Portland, and Mr. James Loving, 4028 N. Michigan, Portland, both active in civic affairs, have been recommended as a representative from the citizens of the City, and said recommendation has been approved by the Mayor; that their expenses should be borne by the Model Cities Fund and it is estimated that the total expenditure will be approximately \$151 for each; now, therefore, the Mayor and Auditor hereby are authorized and directed to draw and deliver two warrants, one payable to Mrs. Billy R. Norman, 2816 N. E. 11th Avenue, Portland, and one payable to Mr. James Loving, 4028 N. Michigan, Portland, each in the sum of \$151, to cover expenses necessarily incurred in the participation of the City Demonstration Agency Directors' meeting scheduled to be held in San Diego, California, January 20, 21 and 22, 1970; Each is scheduled to participate on January 21 and 22, 1970, said sums shall be charged to the Model Cities Administration, Travel and Transportation (6683.310). Mrs. Norman and Mr. Loving shall each file an accounting of expenses, with receipts when possible, with the City Auditor, and any remaining money shall be returned to the City Treasurer.


Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that necessary arrangements may be made for participation in said conference; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
