

ORDINANCE No. 130855


An Ordinance fixing the rate of pay for the job title of Technical Assistant to the Administrative Coordinator in the Model Cities Administration at salary range No. 46, authorizing a salary at Step B for Tom Brumm, incumbent, and declaring an emergency.

The City of Portland ordains:


Section 1. The Council finds that Ordinance No. 129331 passed July 10, 1969, created a position of Technical Assistant to the Administrative Coordinator in the Model Cities Administration and fixed the salary at \$349.60 bi-weekly; that Tom Brumm has served in this position for ten months; that the Acting Director of Model Cities has requested the adjustment of the salary for this position because of increasing responsibilities assigned to it; that the Mayor as Commissioner in charge has recommended assigning salary range No. 46 to this position and authorizing adjustment of the salary of Tom Brumm to Step B which is \$404.80 bi-weekly; and that the salary range for this position and the salary for Mr. Brumm should be adjusted as recommended; now, therefore, the position of Technical Assistant to the Administrative Coordinator in Model Cities Administration (6683.111) is hereby assigned salary range No. 46; further, the salary for Tom Brumm, incumbent in said position, is hereby authorized at Step B of said salary range.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in adjusting the salary for the position of Technical Assistant to the Administrative Coordinator as provided in Section 1 of this ordinance; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
