

ORDINANCE NO. 131000

An Ordinance authorizing the issuance of a free license for the Emanuel Hospital Gift Shop as a non-profit organization, authorizing and directing refund of \$50 of the license fee previously paid by the Emanuel Hospital Gift Shop for the period from and after June 1, 1970, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Emanuel Hospital Gift Shop has heretofore filed financial reports and paid license fees as a profit organization; the Council further finds that the Emanuel Hospital Gift Shop is wholly owned by the Emanuel Hospital, a non-profit corporation; the Council finds that the Emanuel Hospital has requested the issuance of a free license, pursuant to Section 7.04.21 of Chapter 7.04 of Title 7 of the Code of the City of Portland, Ordinance No. 130672; that the Council further finds that the Bureau of Licenses has recommended, and the Commissioner in charge of the Bureau of Licenses, has approved the recommendation that Emanuel Hospital be granted a free license for their gift shop; the Council also finds that the Emanuel Hospital Gift Shop has previously paid the license fee for the calendar year 1970 in the sum of \$100, and that in view of the granting of the free license a partial refund of the sum of \$50 attributable to the second half of 1970 should be made; now, therefore, the Council hereby authorizes the issuance of a free license to Emanuel Hospital for their gift shop and the refund of \$50 of the license fee previously paid by Emanuel Hospital on behalf of its gift shop, all as provided in Section 7.04.21 of Chapter 7.04 of Title 7 of Ordinance No. 130672, the Code of the City of Portland, Oregon, and notwithstanding any contrary provisions of Ordinance No. 130672, the Code of the City of Portland, Oregon.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that the financial affairs of the City may be promptly settled; therefore, an


emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.


