

ORDINANCE No. 131488

An Ordinance creating two positions of Stenographer Clerk in lieu of two positions of Typist Clerk for Model Cities Program Administration, fixing the rate of pay, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that two positions of Typist Clerk in the budget for Model Cities Program Administration are vacant; that the new Model Cities Director has requested an up-grading of these two positions to Stenographer Clerk in order to obtain employees with shorthand ability; that the Mayor as Commissioner in charge has recommended up-grading said positions; and that it would be in the best interest of the City of Portland to provide two positions of Stenographer Clerk as recommended; now, therefore, two positions of Stenographer Clerk are hereby created in the Model Cities Fund appropriation Model Cities Program Administration (6683.111) in lieu of two positions of Typist Clerk. Salary for the new positions is hereby fixed at salary range No. 23 in accordance with the current Compensation Plan.



Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that there may be no unnecessary delay in creating two positions of Stenographer Clerk for Model Cities Program Administration; therefore, an emergency is hereby declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.


