ORDINANCE No. 129957

An Ordinance transferring appropriation in the amount of \$53,259.86 within the Model Cities Fund from Model Cities Projects, General Operating Contingencies (6684.798) to Model Cities Administration, Operation and Maintenance (6683.690) in order to provide for repayment of monies advanced by the General Fund for Model Cities program during the previous fiscal year, authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that, under the provisions of Ordinance No. 128463 passed by the Council January 30, 1969 and Ordinance No. 128931 passed by the Council April 24, 1969, advances by the General Fund were authorized for the Model Cities program between February 1 and June 30, 1969, in the total amount of \$59,171.; that actual expenditures during that period for Model Cities programs amounted to \$53,259.86; that any costs incurred by the General Fund in connection with the Model Cities programs during that period were to be reimbursed as soon as federal monies became available; that federal monies have now been placed on deposit in the Model Cities Fund; that no provision was made in the Model Cities Fund appropriation for the current fiscal year to repay said advances made by the General Fund in the previous year and that a transfer of appropriation within the Model Cities Fund should now be made in order that such advances be repaid; now, therefore, appropriation in the amount of \$53,259.86 is hereby transferred within the Model Cities Fund from Model Cities Projects, General Operating Contingencies (6684.798) to Model Cities Administration, Operation and Maintenance (6683.690). The Mayor and Auditor are hereby authorized to draw and deliver a warrant in the amount of \$53,259.86 payable to the City Treasurer as repayment of monies advanced by the General Fund to the Model Cities program during the previous fiscal year.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That it is necessary to authorize the transfer of appropriation and the repayment of advances described in Section 1 of this ordinance without delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
