

ORDINANCE No. 126885

An Ordinance extending to June 17, 1968, the time for De Leuw, Cather & Company to complete Items 1 through 6 of Part C of agreement for engineering services for proposed parking garage in Block 9, South Auditorium Urban Renewal Project--Area II, and declaring an emergency.

The City of Portland ordains:


Section 1. The Council finds that under date of July 28, 1967, an agreement for engineering services for a proposed parking garage on Block 9, South Auditorium Urban Renewal Project--Area II, was entered into between De Leuw, Cather & Company, an Illinois corporation, offices in San Francisco, California; that the City by Resolution No. 30157, adopted by the Council January 24, 1968, authorized the said company to proceed with Part C, Final Design Services, the said services to be completed within 120 days from and after January 24, 1968; that owing to a delay in the arrival of soils engineering report, the agreement to complete in 120 days was impossible to achieve and an extension to and including June 17, 1968, should be authorized; now, therefore, extension of time to and including June 17, 1968, hereby is granted to De Leuw, Cather & Company, San Francisco, California, to complete Items 1 through 6 of Part C of the agreement entered into between the said company and the City of Portland, dated July 28, 1967, and authorized by Resolution No. 30157, adopted by the Council January 24, 1968.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the city of Portland in this: In order that extension of time may be granted without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
