ORD INANCE NO. 127674

An Ordinance waiving the provisions of Section 16-2022 of the Police Code to permit temporary placement of signs upon utility poles by the Multnomah County Department of Medical Services within the Model Cities area, under certain conditions, and declaring an emergency.

The City of Portland ordains:

The Council finds that the Multnomah County Department of Medical Services, which also administers the health department functions of the City of Portland, has requested waiver of the provisions of Section 16-2022 of Ordinance No. 76339, the Police Code, in order to allow temporary placement of signs on utility poles within the Model Cities area; that such proposed signs are intended to designate certain areas for collection of refuse and debris within the area in connection with a cleanup that waiver of the aforementioned code provision should be authorized, subject to the condition that the Multnomah County Department of Medical Services shall obtain permission of the utility company or companies upon which such signs shall be placed, and upon the further condition that the signs be removed immediately after pickup of the refuse and debris on September 28, 1968; now, therefore, the provisions of Section 16-2022 of Ordinance No. 76339, the Police Code, are hereby waived, in order to allow the Multnomah County Department of Medical Services to place certain signs upon utility poles within the Model Cities program, upon condition that said Multnomah County Department of Medical Services shall obtain permission of the appropriate utility company upon which such signs are placed, and shall further remove such signs immediately after conduct of the pickup campaign on September 28, 1968.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order that waiver of the aforementioned code provision may be made prior to September 28

therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
