

An Ordinance authorizing the Street Commissioner to grade and plank a portion of front Street.

Sec 1 The people of the City of Portland do ordain as follows, that the Street Commissioner be and he is hereby authorized and required to plank and grade so much of front Street as the owner of the property adjoining or abutting on the west side thereof shall neglect or refuse to plank and grade as provided by the City ordinances.

Sec 2 That the expense of planking and grading as provided in section one of this ordinance shall be paid by the property holders adjoining or abutting on the west side of said Street in proportion to the amount so expended by said Street Commissioner, and provided the owner or owners of any property so ordered to be planked and graded shall refuse or neglect to pay for the same the Street Commissioner is hereby authorized to collect the same by law.

Sec 3 That all the planking and grading provided for by section one of this ordinance shall be done under the direction of the Street Commissioner and in accordance with the plans and specifications for grading and planking front Street.

An Ordinance authorizing the Street Commissioner, to grade and plank a portion of front street,

Sect 1st — The people of the City of Portland do ordain as follows. That the Street Commissioner be and he is hereby authorized and required, to plank and grade so much of front street, as the owners of the property adjacent or abutting on the west side thereof, shall neglect or refuse to plank and grade as provided by the City ordinances,

Sect 2nd — That the expense of planking and grading as provided in section one of this ordinance shall be paid by the property holders adjacent or abutting on the west side of said street in proportion to the amount so expended by said Street Commissioner, and provided the owner or owners of any property, so ordered to be planked and graded shall refuse or neglect to pay for the same, the Street Commissioner is hereby authorized to collect the same by law,

Sect 3rd — That all the planking and grading provided for by section one of this ordinance shall be done under the direction of the Street Commissioner, and in accordance with the plans and specifications for grading and planking front street,

Sect 4th — This ordinance shall take effect and be in force from and after its adoption.
