Creating an equitable Climate Investment Plan (CIP) requires meaningful participation from the community. We are grateful for your commitment to strengthening the CIP by giving us feedback. We received over 500 comments from a diverse group of stakeholders. They include community members, nonprofit organizations, business owners, and government institutions. We also held two community review panels. These included community voices most impacted by climate change.

### Our process

We read through all feedback from the various outreach efforts. We incorporated changes that balanced:

- Community need and empowerment.
- Greenhouse gas reductions or sequestration.
- Implementation feasibility.

At least two members of our team read every comment with careful consideration. Any changes must be aligned with the scope and mission of
